Commodity EXIM Report DGCI&S, I T J Division

- 1. The weekly EXIM Report published by ITJ Division of DGCI&S, Kolkata presents some basic insights into India's export and import trade patterns with respect to selected set of commodities identified each week in order to facilitate preliminary commodity group/sector specific analysis for informed trade decision making.
- 2. For both categories of trades, one commodity group is chosen from the entire ITC-HS 4-digit Classification (latest being 2024 classification system). The Indian Trade Classification based on Harmonized System has been adopted in India for Export and Import Operations. While India specific data is sourced from DGCI&S, M/o C&I Database, global export-import data of exactly those sets of commodities are sourced from UN-COMTRADE Database.
- 3. As regards the time-period, this report outlines trade statistics over a period of four years, i.e., 2021 to 2024. The latest finalized data available on the UN Comtrade Database is only up to year 2024and on the DGCI&S Database up to September, 2025. So, for each commodity group dealt in this report, trends from 2021 to 2024 have been showcased where data has been sourced from UN Comtrade and from DGCI&S database.
- 4. In the instant report [1st weekly Commodity Exim Report of December, 2025 dated 3rd December, 2025] the following two commodities have been dealt with.

Export :Electrical Transformers, Static Converters (for example, Rectifiers) and Inductors [ITCHS Code –8504] -In 2024 this commodity group had 0.68% share in India's total Export value basket as per DGCI&S database. As per UN Comtrade database India occupied the 12th slot in export of this commodity (2978.36 million USD) with 1.95% share of total global exports in the year 2024.

Import: Natural Calcium Phosphates, Natural Aluminium Calcium Phosphates and Phosphatic Chalk [ITCHS Code –2510] - In 2024 this commodity group had share of 0.25% in India's total Import value basket as per DGCI&S database. India having 40.29% share of total global imports of this commodity (1791.24 million USD) occupied the top slot in the world in 2024.

EXPORT

Electrical Transformers, Static Converters (for example, Rectifiers) and Inductorsclassified as H.S. Code – 8504 falls under Chapter -85 (Electrical machinery and equipment and parts thereof; sound recorders and reproducers, television image and sound recorders and reproducers, and parts and accessories of such articles) of Section-XVI (Machinery & their Parts, Electrical & Electronic Equipment, Parts thereof) of ITC-HS classification. India is engaged in the process of exporting this commodity and in 2024 this commodity group had 0.68% share in India's total Export value basket as per DGCI&S database.



India's top 10 destinations of Electrical Transformers, Static Converters and Inductorsby percentage share in 2024




The total value of exports of Electrical Transformers, Static Converters and Inductorsfrom India amounted to USD3024.36 million in 2024, increasedby 6% compared to 2023figures of USD 2853.19 million. For, the period under review, exports in this segment were at USD 2147.30 million in 2021 and increased till 2024. USA (USD 1036.81million) held the top slot as an export destination in this segment from India with 34.28% share of India's total exports in 2024 followed distantly by UK (USD 185.44 million) and Netherlands (USD 170.32 million) to where India exported around 6.13% and 5.63% share of total Electrical Transformers, Static Converters and Inductors respectively in2024.



World's 10 leading exporters of Electrical Transformers, Static Converters and Inductors(percentage share in 2024):




Converters Electrical Transformers, Static The global export of and Inductorsreached USD153096.97million in 2024, decreased by 2.92% over the previous year. The lead exporter in this segment has consistently been China (exporting goods worth a total of USD46370.80million) with a show of 30.29% share globally in 2024. Germany (USD12302.12 million) and USA(USD8085.47 million) stood at 2nd and 3rd slot in the world with 8.04% and 5.28% share of world exports in this segment in 2024. India (exporting goods worth a total of USD2978.36 million in this category) with 1.95% share, stood at 12th slot in 2024 of world export in this segment. Over the years as observable from 2021 to 2024 in above table global export value in this segment increased till 2023then decreased in 2024.



Top 10 importers of Electrical Transformers, Static Converters and Inductors from 2021 to 2024Data labels signified for 2024




World's 10 leading importers of Electrical Transformers, Static Converters and Inductorspercentage share in 2024




Worldwide Imports of Electrical Transformers, Static Converters and Inductorswas USD146637.03million in 2024, decreased by 5.30% from 2023 levels. The lead importers in this segment in 2024 were USA (20.32%), Germany (8.28%) and China (6.94%). **India**with 2.40% share in this category, stood at 12th position globally.Global imports in this segment declined in 2024 compared to the year 2023and steadily increased from 2021 till 2023. India was the 12th largest exporter as well as the 12th largest importer of this product in 2024 and eight-digit item wise analysis may provide us insightful facts subsequently.

As per UN Comtrade database the top 3 importers of Electrical Transformers, Static Converters and Inductorswere **USA**, **Germany and China**. These three country USA, Germany and China imported 3.45%, 1.04% and 1.38% share of their total import of this commodity from India in 2024 which are presented below:


(i) Top 3 supplier nations of Electrical Transformers, Static Converters and Inductors to USA in 2024 (percentage share)

India is engaged in the process of importing this commodity and in 2024 this commodity group had share of 0.25% in India's total Import value basket as per DGCI&S database.

In 2024 India imported a total of USD 1818.24million worth of Natural Calcium Phosphates, Natural Aluminium Calcium Phophates and Phosphatic Chalkincreased by 10.59% compared to the year 2023. As per available dataJordanwas India's top importing partner in this segment with a share of 41.43%, followed distantly by Morocco and nextby Togo with shares of 17.40% and 15.87% respectively. India's import value in this segment had a huge jump in 2022 over 2021 levels, then decreased in 2023 and again increased in 2024.

Worldwide import of Natural Calcium Phosphates, Natural Aluminium Calcium Phosphates and Phosphatic Chalk totalled to USD 4445.75 million in 2024, increased by 6.48% over 2023 levels. **India** imported USD 1791.24million worth of the commodity in 2024, making it the leading importer of the commodity group worldwide with 40.29% share of world imports. USA (9.86%) and Belgium (4.70%) lined up in second and third place in 2024. Global import value of goods in this segment increased in 2022 from 2021 level and then decreased in 2023 and in 2024 it increased again.
