

Interested contractors who wish to participate should remit online transaction fee for tender after registering in the e-portal. The transaction fee is non-refundable. The technical bids along with EMD and financial bids are to be submitted in e-portal as per the instructions in the bidding documents.

The technical bids of the Agencies who satisfy the requirement of payment of EMD and other terms as per bidding documents will be opened first and the financial bids of the technically qualified bidders as per prescribed prequalification criteria will be considered.
