The weekly EXIM Report published by ITJ Division of DGCI&S, Kolkata presents some basic insights into India's export and import trade patterns w.r.t. selected set of commodities identified each week in order to facilitate preliminary commodity group/sector specific analysis for better policy making.

2. For both categories of trades, one commodity group is chosen from the entire ITC-HS 4-digit Classification (latest being 2023-2024 classification system). The Indian Trade Classification based on Harmonized System has been adopted in India for Export and Import Operations. While India specific data is sourced from DGCI&S, M/o C & I Database, global export-import data of exactly those sets of commodities are sourced from UN-Comtrade Database.

3. As regards the time-period, this report outlines trade statistics over a period of four years. Currently (for reports being prepared in FY 2023- 2024) we are considering the time-period of 2020-2021 to 2023-2024(Financial year data). The latest finalized data available on the UN Comtrade Database is only up to year 2023 (Calendar Year) and on the DGCI&S Database up to May, 2024. So, for each commodity group dealt in this report, trends from 2020 to 2023 have been showcased where data has been sourced from UN Comtrade and from 2020-2021 to 2023-2024 when sourced from DGCI&S database; however, for computation of commodity group's share in India's overall export and import basket we had to use FY (financial year) data as all aggregate level data in India are represented in FY format.

4. In the instant report [3rd weekly Commodity Exim Report of June, 2024 dated 19th June, 2024] the following two commodities have been dealt with.

Export : Foot wear with outer soles of Rubber, Plastics, Leather etc [ITCHS Code –6403] -In FY 2023-2024 (April,2023 –March,2024) this commodity group has 0.41% share in India's total Export value basket as per DGCI&S data base. India had occupied the 3rd slot in export of this commodity (1835.31 million USD) with 4.23% share of total global exports in the year 2023.

Import : Coconuts, Brazil nuts and Cashew nuts Fresh or Dried [ITCHS Code – 0801] –In FY 2023-24 (April 2023 – March, 2024) this commodity group had share of 0.21% in India's total Import value basket as per DGCI&S data base. India having 11.73% share of total global imports of this commodity (3350.23 million USD) occupied the top slot in the world in 2023.

EXPORT

Foot wear with outer soles of Rubber, Plastics, Leather etc classified as H.S. Code – 6403 falls under Chapter -64 (Footwear, gaiters and the like; parts of such articles) of Section XII (Footwear, Headgear, Umbrellas; Prepared Feathers and Articles thereof) of ITC-HS classification.

India is engaged in the process of exporting this commodity and in 2023-2024 FY this commodity group has so far had 0.0.41% share in India's total Export value basket as per DGCI&S data base.



India's top 10 destinations of Foot wear with outer soles of Rubber, Plastics, Leather etc by percentage share in 2023-2024



In the year 2023-2024 India has exported Foot wear with outer soles of Rubber, Plastics, Leather etc worth of US \$ 1809.90 million and registered a decrease of 15.79% compared to 2022-2023 figures of US \$ 2149.13 million. For, the period under review, exports of this commodity group were at US\$1319.99 million in 2020 -2021 followed by persistent rise up to the year 2022-2023 and a down turn in 2023-2024. USA (importing US\$ 353.33 million worth of goods in this segment from India) has held the top slot as an export destination in this segment with 19.52% share of India's total exports of Foot wear with outer soles of Rubber, Plastics, Leather etc recorded for the 2023-2024. In second and third place were UK (US\$ 231.68 million) and Germany (US\$ 198.83 million) to where India exported around 12.80% and 10.99% share of total Foot wear with outer soles of Rubber, Plastics, Leather etc respectively in 2023-2024.




 World's Top 10 exporters of Foot wear with outer soles of Rubber, Plastics, Leather etc (H.S Code-6403)

The Foot wear with outer soles of Rubber, Plastics, Leather etc exports worldwide was US \$ 43420.48 million in 2023, with a decrease by 25.50% compared to 2022 levels. Over the period under review, global export were at record high at US\$ 58282.33 million in 2022. **India** (exporting goods worth a total of US\$ 1835.31 million in this category) with a show of 4.23% share, stood at 6th position globally. The lead Exporter in this segment has presently been Italy (exporting goods worth a total of US\$ 8925.53 million) with 20.56% share of world export in 2023, followed by China (US\$ 8488.02 million) with 19.55% and Germany (US\$ 4822.14 million) with 11.11% share in 2023 respectively.




 World's top 10 Importers of Foot wear with outer soles of Rubber, Plastics, Leather etc (H.S Code-6403)

Top 10 Importers of Foot wear with outer soles of Rubber, Plastics, Leather etc globally from 2020 to 2023 Data labels signified only for 2023




World's 10 leading importers of Foot wear with outer soles of Rubber, Plastics, Leather etc by percentage share in 2023



The Foot wear with outer soles of Rubber, Plastics, Leather etc imports worldwide was US\$ 51883.47 million in 2023, decreasing by 11.31% from 2022 levels. Over the period under review, global imports were at record high at US\$ 58499.43 million in 2022. The lead importers in this segment in 2022 have been USA (22.26%), Germany (10.24%), and France (7.86%) and **India** with a show of only 0.23% share, Stood at 41^{st} position.


A difference is observed between global exports and global imports of this segment as recorded in UN Comtrade database. In 2023 global imports exceeded global exports by US\$ 8463.01 million.

As per UN Comtrade database the top 3 importers of New Pneumatic Tyres of Rubber globally were **USA**, **Germany and France.** These 3 country had imported 3.39%, 6.71% and 2.64% share of their total import of this commodity from India in 2023.




Top 3 supplier nations of Foot wear with outer soles of Rubber, Plastics, Leather etc to USA in 2023 (percentage share)

These machines are imported for diversified use in India's vibrant Textile Sector.

The total amount of India's import of Coconuts, Brazil nuts and Cashew nuts Fresh or Dried in 2023 stood as US\$ 3354.89 million registering almost flat level growth compare to the year 2022 figures of US\$ 3361.26 million. In 2023 China stood out as the top importing partner in this segment with a share of 31.72% followed by Japan(16.22%) and Taiwan (12.03%). India's import in this segment in 2020 was US \$ 1785.56 million followed next increasing trends till 2022 with a significant leap in the 2021 levels.

In 2023, the total global imports of Coconuts, Brazil nuts and Cashew nuts Fresh or Dried amounted to US\$ 28567.7 million, increasing by more than 3.42% vis-à-vis the previous year's figure. In 2022, **India** has occupied the top position by way of importing up to 11.73 % of global imports of Coconuts, Brazil nuts and Cashew nuts Fresh or Dried. 2nd and 3rd major importing countries were Germany and USA with 6.69% and 6.07% shares respectively. Import share in this segment has been steadily increasing over the years as observable from 2020 to 2023 in above table with a dip recorded in 2020 and with a significant leap in the year 2022. Quite strikingly on one hand USA is one of the major importers of this product(occupying the 3rd slot) and on the other hand USA is India's one of the major source country for importing this commodity.
