# Commodity EXIM Report DGCI & S, I T J Division

The weekly EXIM Report published by ITJ Division of DGCI&S, Kolkata presents some basic insights into India's export and import trade patterns w.r.t. selected set of commodities identified each week in order to facilitate preliminary commodity group/sector specific analysis for better policy making.

2. For both categories of trades, one commodity group is chosen from the entire ITC-HS 4-digit Classification (latest being 2023-2024 classification system). The Indian Trade Classification based on Harmonized System has been adopted in India for Export and Import Operations. While India specific data is sourced from DGCI&S, M/o C & I Database, global export-import data of exactly those sets of commodities are sourced from UN-COMTRDADE Database.

3. As regards the time-period, this report outlines trade statistics over a period of four years. Currently (for reports being prepared in FY 2023- 2024) we are considering the time-period of 2020-2021 to 2023-2024. The latest finalized data available on the UN Comtrade Database is only up to year 2023 (Calendar Year) and on the DGCI&S Database up to December,2024. So, for each commodity group dealt in this report, trends from 2020 to 2023 have been showcased where data has been sourced from UN Comtrade and from 2020-2021 to 2023-2024 when sourced from DGCI&S database; however, for computation of commodity group's share in India's overall export basket and import basket we have had to use FY (financial year) data as all aggregate level data in India are represented in FY format.

4. In the instant report [4<sup>th</sup> weekly Commodity Exim Report of February,2025 dated 26<sup>th</sup> February, 2025] the following two commodities have been dealt with.

**Export : Essential Oils; Resinoids; Extracted Oleoresins etc.** [**ITCHS Code –3301**] -In FY 2023-2024 this commodity group has 0.21% share in India's total Export value basket as per DGCI & S data base. India had occupied the top slot in export of this commodity (exported 909.05 million USD) with 16.31% share of total global exports in the year 2023.

**Import : Flat- Rolled Products of Stainless Steel, of Width of 600 mm or more. [ITCHS Code – 7219]** – In FY 2023-24 this commodity group had share of 0.24% in India's total Import value basket as per DGCI&S data base. India having 5.31% share of total global imports of this commodity (1633.70 million USD) occupied the 6<sup>th</sup> slot in the world in 2023.


**Essential Oils; Resinoids; Extracted Oleoresins etc** classified as **ITCHS Code** – **3301** falls under Chapter - 33(Essential Oils, Including Concretes and Absolutes; Resinoids, Extracted Oleoresins; Concentrates pf Essential Oils in Fats, In Fixed Oils, In Waxes or the Like, Obtained by Enfleurage or Maceration; Terpenic By-Products of the Deterpenation of Essential Oils; Aqueous Distillates and Aqueous Solutions of Essential Oils ) of Section- VI (Essential oils and resinoids, perfumery, cosmetic or toilet preparations) ITC-HS classification. India is engaged in the process of exporting this commodity and in 2023-2024 FY this commodity group has so far had 0.21% share in India's total Export value basket as per DGCI&S data base.

India's top 10destinations of Essential Oils; Resinoids; Extracted Oleoresins etc by Percentage in 2023-2024



The total value of exports of Essential Oils; Resinoids; Extracted Oleoresins etc from India amounted to US\$ 924.67 million in 2023-2024, very little declining by 0.38% from 2022-2023 levels. USA (US\$ 271.02 million) has held the top position as an export destination in this segment from India with 29.31% share of India's total export. Followed by China (US\$ 98.55 million) and Malaysia (US\$ 71.44 million) to where India exported around 10.66% and 7.73% share of Essential Oils; Resinoids; Extracted Oleoresins etc respectively in 2023-2024. For the period under review, exports of Essential Oils; Resinoids; Extracted Oleoresins etc from India were at US\$ 875.25 million in 2020-2021 followed by an incremental trend and steep rise in 2021-2022 and down turn in 2022-2023 and 2023-2024.




 World's Top 10 exporters of Essential Oils; Resinoids; Extracted Oleoresins etc (HS Code – 3301)

The Essential Oils; Resinoids; Extracted Oleoresins etc exports globally soared to US\$ 5574.19 million in 2023 very little increasing by 0.47% over the previous year. **India** occupied the top position with 16.31% share of world exports of Essential Oils; Resinoids; Extracted Oleoresins etc totaling to US\$ 909.05 million, closely followed by USA (US\$ 746.32 million) and Brazil (US\$ 476.57 million), occupied the 2<sup>nd</sup> and 3rd slots with the highest levels of exports in 2023, with 13.39% and 8.55% shares of global exports of Essential Oils; Resinoids; Extracted Oleoresins etc respectively. India's share has gradually been increased from 2020 to 2022 and closely falls in 2023.




 World's Top 10 Importers of Essential Oils; Resinoids; Extracted Oleoresins etc (HS Code – 3301)

Leading Importers of Essential Oils; Resinoids; Extracted Oleoresins etc globally from 2020 to 2023 (Data labels signified for 2023)




World's 10 leading importers of Essential Oils; Resinoids; Extracted Oleoresins etc (by percentage share in 2023)




The Essential Oils; Resinoids; Extracted Oleoresins etc imports worldwide was US \$ 5596.36 million in 2023, decreasing by 2.62% from 2022 levels. Over the period under review, global imports were at record high in 2022. **India** (importing goods worth a total of US\$ 419.98 million in this category with a show of 7.50%, stood at the  $3^{rd}$  slot in 2023 of world export of Essential Oils; Resinoids; Extracted Oleoresins etc . The lead importers in this segment in 2023 have been USA(20%) and France( 7.77%). India's share in this segment has been steadily increasing over the years as observable from 2020 to 2023.

As per UN Comtrade date base the top 3 importers of Essential Oils; Resinoids; Extracted Oleoresins etc globally were **USA**, **France and India**. Out of these three countries, USA and France have imported 16.23% and 9.10% share of Essential Oils; Resinoids; Extracted Oleoresins etc from India in 2023 which are presented below :

### **IMPORT**

**Flat- Rolled Products of Stainless Steel, of Width of 600 mm or more** classified as ITCHS Code -7219 falls under Chapter -72 (Iron and steel) of Section -XV (Base Metals and Articles of Base Metal ) of ITCHS classification.

India is engaged in the process of exporting this commodity and in FY 2023 –24 this commodity group had share of 0.24% share in India's total Import value basket as per DGCIS data base.

In 2023-2024 India had imported a total of USD 1643.90 million worth of Flat- Rolled Products of Stainless Steel, of Width of 600 mm or more. As per available data, China stood out as India's top importing partner in this segment with a share of 39.62%, followed by Hong Kong and next Korea RP with shares of 11.62% and 9.81% respectively. India's import value in this segment had a huge jump in 2021-22 over 2020-21 with a continuing trend till 2022-23 and a slight dip in 2023-24.

Worldwide import of Flat- Rolled Products of Stainless Steel, of Width of 600 mm or more totaled US\$ 30761.66 million in 2023 recording a 31.80% down over 2022 levels. Germany imported US\$ 3867.69 million worth of this commodity in 2023, making it the leading importer of the commodity group worldwide with 12.57% share of world imports. Italy (9.98%) and China (8.62%) lined up in second and third place in 2023. The import value of Flat- Rolled Products of Stainless Steel, of Width of 600 mm or more **India** ranked 6<sup>th</sup> in the world with the share of 5.31% of total global import value of goods in this segment experiencing a major dip from US\$ 1688.66 million in 2022 to 1633.70 million.
