## Commodity EXIM Report DGCI & S, I T J Division

The weekly EXIM Report published by ITJ Division of DGCI&S, Kolkata presents some basic insights into India's export and import trade patterns w.r.t. selected set of commodities identified each week in order to facilitate preliminary commodity group/sector specific analysis for better policy making.

- 2. For both categories of trades, one commodity group is chosen from the entire ITC-HS 4-digit Classification (latest being 2023-2024 classification system). The Indian Trade Classification based on Harmonized System has been adopted in India for Export and Import Operations. While India specific data is sourced from DGCI&S, M/o C & I Database, global export-import data of exactly those sets of commodities are sourced from UN-COMTRDADE Database.
- 3. As regards the time-period, this report outlines trade statistics over a period of four years. Currently (for reports being prepared in FY 2023- 2024) we are considering the time-period of 2020-2021 to 2023-2024. The latest finalized data available on the UN Comtrade Database is only up to year 2023 (Calendar Year) and on the DGCI&S Database up to June,2024. So, for each commodity group dealt in this report, trends from 2020 to 2023 have been showcased where data has been sourced from UN Comtrade and from 2020-2021 to 2023-2024 when sourced from DGCI&S database; however, for computation of commodity group's share in India's overall export basket and import basket we have had to use FY (financial year) data as all aggregate level data in India are represented in FY format.
- 4. In the instant report [3rd weekly Commodity Exim Report of August, 2024 dated 21st August, 2024] the following two commodities have been dealt with.

**Export : Meat of Bovine Animals, Frozen [ ITCHS Code –0202] -**In FY 2023-2024 this commodity group has 0.77% share in India's total Export value basket as per DGCI&S data base. India had occupied the 4<sup>th</sup> slot in export of this commodity (exported 3188.06 million USD) with 9.86% share of total global exports in the year 2023-2024.

Import: Antibiotic [ ITCHS Code – 2941 ] –In FY 2023-24 this commodity group had share of 0.29% in India's total Import value basket as per DGCI&S data base. India having 20.96% share of total global imports of this commodity (1963.88 million USD) occupied the top slot in the world in 2023-2024.

## **EXPORT**

**Meat of Bovine Animals, Frozen** classified as H.S. Code – 0202 falls under Chapter -02 (Meat and edible meat offal) of Section I (Live Animals; Animal Products) of ITCHS classification.

India is engaged in the process of exporting this commodity and in 2023-2024 FY this commodity group had share of 0.77% in India's total Export value basket as per DGCI & S data base.



India's top 10 destinations of Meat of Bovine Animals, Frozen Exports in 2023-2024 (Percentage share)




The total of exports of Meat of Bovine Animals, Frozen from India amounted to US\$ 3363.86 million in 2023-2024 and registered an increase of 17.63% compared to 2022-2023 figures of US\$ 2859.72 million. For, the period under review, exports of this segment were at US\$ 2851.94 million in 2020-2021 followed by moderate rise in 2021-2022 and then decrease in 2022-2023 and then picked in 2023-2024. Vietnam (US\$ 580.08 million) has held the top slot as an export destination of Meat of Bovine Animals, Frozen from India with 17.24% share of India's total export followed closely by Malaysia( US\$ 564.63 million) and Egypt (US\$ 524.37 million) to where India exported around 16.79% and 15.59% share of total export of Meat of Bovine Animals, Frozen respectively in 2023-2024.



The global export of Meat of Bovine Animals, Frozen exports worldwide reached US \$ 32318.35 million in 2023 a little declining by 15.34% from 2022 levels. The lead exporter in this segment has consistently been Brazil (exporting goods worth a total of US\$ 8533.09 million) with a show of 26.40% share in 2023. Australia (US\$ 4806.45 million) and USA (US\$ 4184.55 million) with 14.87% and 12.95% share of world exports in this segment in 2022 stood at 2<sup>nd</sup> and 3<sup>rd</sup> slots respectively. **India** (exporting goods worth a total of US\$ 3188.06 million in this category) with a show of 9.86% share, stood at 4<sup>th</sup> slot in 2023 of world export of Meat of Bovine Animals, Frozen.





The Meat of Bovine Animals, Frozen imports worldwide was US\$ 26195.70 million in 2023, huge decreasing by 30.46% from 2022 level of US \$ 37668.63 million. The lead importers globally in this segment in 2023 had been China (51.45%) followed by USA (12.27%), and Japan (5.17%) and **India** had no import trade in this segment as per UN Comtrade database between 2020-2023. Over the period under review, global import were at record high in 2022 continue rising from 2020 to 2022 with a steep leap in 2022 and huge dip in 2023.

A difference is observed between global exports and global imports of this segment as recorded in UN Comtrade database. In 2023 global exports exceeded global imports by US\$ 6122.65 million.

## **IMPORT**

**Antibiotic** Classified as ITCHS Code 2941 falls under Chapter-29(Organic chemicals) of Section – VI (Products of the Chemical or Allied Industries) of ITCHS classification. India is engaged in the process of importing this commodity and in 2023-2024 this commodity group had share of 0.47% in India's total import value basket.

The total amount of India's import Antibiotics in 2023-2024 stood as US\$ 1990.26 million registering an increasing by 20.46% compare to the year 2022-2023 figures of US\$ 1652.06 million. In 2023-2024 China stood out as the top importing partner in this segment from where India has imported 84.81% share of it total import of Antibiotic, distantly followed by Hong Kong (3.01%) and Austria (2.18%). Over the period under review India's imports in this segment has steadily been rise in 2021-2022 compare to the year 2020-2021 followed minor decrease in 2022-2023 and then a major leap in 2023-2024.

In 2023, the total global imports of Antibiotics amounted to US \$ 9371.18 million, decreasing by more than 11.90% vis-à-vis the previous year's figure. The lead Importer in this segment has consistently been **India** (importing goods worth a total of US\$ 1963.88 million) with 20.96% share of world import in 2023. Italy (importing goods worth a total of US\$ 1105.85 million in this category) with a show of 11.80% share, stood at 2<sup>nd</sup> position; followed by USA (US\$ 721.57 million) with 7.70% share in 2023 as per UN Comtrade Statistics.
