Export – Import (EXIM Report) DGCI & S, I T J Division

The weekly EXIM Report published by ITJ Division of DGCI&S, Kolkata presents some basic insights into India's export and import trade patterns w.r.t. selected set of commodities identified each week in order to facilitate preliminary commodity group/sector specific analysis for better policy making.

- 2. For both categories of trades, one commodity group is chosen from the entire ITC-HS 4-digit Classification (latest being 2023-2024 classification system). The Indian Trade Classification based on Harmonized System has been adopted in India for Export and Import Operations. While India specific data is sourced from DGCI&S, M/o C & I Database, global export-import data of exactly those sets of commodities are sourced from UN-COMTRDADE Database.
- 3. As regards the time-period, this report outlines trade statistics over a period of four years. Currently (for reports being prepared in FY 2023- 2024) we are considering the time-period of 2020-2021 to 2023-2024. The latest finalized data available on the UN Comtrade Database is only up to year 2023 (Calendar Year) and on the DGCI&S Database up to October,2024. So, for each commodity group dealt in this report, trends from 2020 to 2023 have been showcased where data has been sourced from UN Comtrade and from 2020-2021 to 2023-2024 when sourced from DGCI&S database; however, for computation of commodity group's share in India's overall export basket and import basket we have had to use FY (financial year) data as all aggregate level data in India are represented in FY format.
- 4. In the instant report [4th weekly Commodity Exim Report of December, 2024 dated 25th December, 2024] the following two commodities have been dealt with.

Export : Cast Articles of Iron or Steel (ITCHS Code- 7325) - In FY2023-2024 this commodity group has 0.29% share in India's total Export value basket as per DGCI&S data base. India had occupied the top slot in export of this commodity with (1240.47 million USD) 15.07 % share of total global exports in the year 2023.

Import: Mineral or Chemical Fertilisers, Nitrogenus (ITCHS Code -3102) – In FY 2023-2024 this commodity group had share of 0.48% in India's total Import value basket as per DGCI&S data base. India having 10.25% share of total global imports of this commodity (USD 3615.79 million) and occupied the 2^{nd} slot in the year 2023.

EXPORT


Cast Articles of Iron or Steel classified as H.S. Code – 7325 falls under Chapter -73 (Articles of iron or steel) of Section XV (Base Metals and Articles of Base Metal) of ITCHS classification.

India is engaged in the process of exporting this commodity and in 2023-2024 FY this commodity group had share of 0.29% in India's total Export value basket as per DGCI & S data base.

In the year 2023-2024, **India** has exported Cast Articles of Iron or Steel worth of US\$ 1249.03 million, with a little decreased by 7.69% compared to 2022-2023 figures of US\$ 1353.20 million. The exports of Cast Articles of Iron or Steel from India were at US\$ 1042.07 million in 2020-2021 followed by a steep up in 2021-2022 and 2022-2023, turn - around in 2023-2024. USA (importing US\$ 331.95 million worth of goods in this segment from India) has held the top slot as an export destination in this segment with 26.58% share of India's total export. In second and third place were Italy (US\$ 114.52 million) and Germany (US\$ 111.86 million) to where India exported around 9.17 % and 8.96 % of the commodity respectively in 2023-2024.





World's 10 leading exporters of Other Cast Articles of Iron or Steel (percentage share in 2023)



The Cast Articles of Iron or Steel exports worldwide was US\$ 8230.74 million in 2023 declining by 8.09% from 2022 levels. Over the period under review, global export were at record high at US\$ 8955.04 million in 2022. The lead Exporter in this segment has consistently **India**(exporting goods worth a total of US\$ 1240.47 million in this category) with a show of 15.07% share in 2023, China (exporting goods worth a total of US\$ 1181.69 million) with 14.36% share of world export in 2023 stood at 2nd position followed by France (US\$ 591.44 million) with 7.19% in 2023. As per UN Comtrade database India's export share has consistently remained more than 15% mark. Quite notably, Germany has held the 3rd slot as an import destination of Other Cast Articles of Iron or Steel with 8.96% share from India, on the other hand Germany as a country is also a leading exporter globally, has held the 4th slot in the world.





Data labels signified for 2023




World's 10 leading importers of Cast Articles of Iron or Steel by percentage share in 2023




The Cast Articles of Iron or Steel imports worldwide was US\$ 6368.11 million in 2023, decreasing by 11.82% from 2022 level of US \$ 7222.16 million. Over the period under review, global import were at record high in 2022 gradually rising from 2020 and a dip in 2023. The lead importers globally in this segment in 2023 have been Germany (10.26%) followed by USA (9.53%), and Italy (8.84 %) and **India** with a show of 1.27% share, occupied the 22nd slot in terms of importing this commodity and as per UN Comtrade database between 2020-2023. Quite notably, Germany has held the top slot as an importer in this segment in on the other hand Germany as a country is also a leading exporter of Cast Articles of Iron or Steel globally, has held the 4th slot in the world. A difference is observed between global exports and global imports of Cast Articles of Iron or Steel as per UN Comtrade statistics; in 2023 global exports exceeded global imports by US\$1862.63 million.

As per UN Comtrade date base the top 3 importers of Cast Articles of Iron or Steel globally were **Germany**, **USA and Italy**. The 3 countries have imported 6.56%, 43.08% and 17.90% share of Cast Articles of Iron or Steel from India in 2023 which are presented below:


(i) Top 3 supplier nations of Cast Articles of Iron or Steel to Germany in 2023 (percentage share)

IMPORT

Mineral or Chemical Fertilisers, Nitrogenus Classified as ITCHS Code 3102 falls under Chapter-31 (Fertilisers) of Section – VI (Products of the Chemical or Allied Industries) of ITCHS classification. India is engaged in the process of importing this commodity and in 2023-2024 this commodity group had share of 0.48% in India's total import value basket. Chapter 31 totally forms a major commodity group in India's overall import basket as well as export basket.

The total amount of India's import in this segment in 2023-2024 stood as US\$ 3266.65 million registering a major decreased by 43.23% over 2022-2023 figures of US\$ 5754.22 million. In 2023 China stood out as the top importing partner in this segment from where India has imported 25.89% share of its total import of Mineral or Chemical Fertilisers, Nitrogenus, closely followed by Russia (22.81%) and Oman (21.13%). Over the period under review India's imports in this segment has steadily been rising from 2020-2021 till 2021-2022 with a major leap in 2021-2022 vis-à-vis 2020-2021 levels and turned down in 2022-2023 and 2023-2024.

In 2023, the total global imports of Mineral or Chemical Fertilisers, Nitrogenus amounted to US \$ 37650.45 million, a major decreasing by more than 40.25% vis-à-vis the previous year's figure. The lead Importer in this segment has consistently been Brazil (importing goods worth a total of US\$ 4437.64 million) with 11.79% share of world import in 2023. **India** (importing goods worth a total of US\$ 3860.47 million in this category) with a show of 10.25% share, stood at 2nd position; followed by USA (US\$ 3549.61 million) with 9.43% share in 2023 as per UN Comtrade Statistics. India's imports in this segment frequented a major dip in 2020 followed by a leap in 2021 and a step up rise in 2022 again followed by steep fall in 2023.
