#### Terms and conditions

- 1. The tender should be given in two bid systems i.e. Technical and Financial (As per prescribed formats in Annexure-I and Annexure-II) duly superscribed with "TECHNICAL BID FOR CRYOVESSEL MAITENANCE" and "FINANCIAL BID FOR CRYOVESSEL MAITENANCE" in two separate sealed envelopes. Both sealed envelopes will be put into one bigger cover duly superscribed with "OFFER FOR RATE CONTRACT FOR CRYOVESSEL MAINTENANCE".
- Bids are to be submitted to the Project Director, Bihar Livestock Development Agency (BLDA), P.O.- Bihar Veterinary College, Patna-800 014 till 12.00 PM on or before 21/03/2024.
- The Bids will be accepted by postal/courier or hand delivery. If the bidders opt for postal/courier delivery, they will be responsible for ensuring that the bids are received on time before the due time.
- 4. The bid will be for the following work(s):
  - i. Leak Test & Evaluation of IOCL make cryogenic vessels to ensure no leakage condition exists or to confirm the presence of leakage by breaking the existing vacuum level by dry nitrogen and all "O" rings attached to the VIC applying combined test methods (pressure-cum-vacuum & evaluation not less than 0.02 millibar (measured by duly calibrated digital Pirani Gauge) of IOCL make Cryogenic vessels.
  - ii. Painting of cryogenic vessels.
  - iii. Civil base construction of IOCL make cryo-vessels.
  - iv. Installation & supervision of commissioning of IOCL make Cryo-vessels (LN2 will be supplied free of cost by BLDA).
- 5. All the attached pages of the tender document should be signed and stamped by the tenderer with the page number and Index.
- 6. The Technical Bid will be opened at the office of the Project Director, BLDA, Patna in the presence of the bidders or their authorized representatives on 21/03/24 at 03.00 PM. The date for the opening of the financial bid will be intimated later. If the last date of the tender happens to be a holiday the next working day will be the last receiving & opening date of the technical bid of the tender.
- 7. The tenderer will have to make an earnest money deposit (EMD) for Rs. 50,000/- (Fifty thousand) in the form of a bank draft drawn on any scheduled bank in favor of the

No interest shall be payable on this amount and shall be deposited as a security deposit with us for such parties who are selected to award work orders. EMD of unsuccessful bidders shall be returned on request.

- 8. The firm will submit proof of GST filing for the last two quarters/six months.
- The bidder will have to submit proof of experience of such work (mentioned in this tender).
- 10. The technical bid should contain the following information and documents duly filled in Annexure I:
  - a. Name and address of the service providers/agencies/firms/manufacturers with telephone number(s) and e-mail address.
  - b. Authorized contact person (name, address, and telephone numbers (s).
  - c. Requisite earnest money deposit.
  - d. Copy of GST, Income Tax Registration.
  - e. Valid GST filing Proof of the last two quarters.
  - f. Proof of filing of Income Tax return of the last three Financial Years
  - g. The bidder will have to submit proof of experience of such work (mentioned in this tender)
  - h. Self-declaration certificate that the bidder has not been blacklisted or there is no any proceeding is going on in any Government/ Semi government institutions in the last two years.
- 11. Only the technically approved offers will be opened for financial evaluation.
- 12. The financial bid should contain: Rate (Rs.) of Quoted works related to IOC make Cryovessels at different locations of Bihar (GST extra).
- 13. The rate quoted by the bidder shall be valid for at least two years from the date of approval, which may be extended on mutual consent for a further one-year period or till the finalization of the next tender.
- 14. A financially qualified bidder has to deposit a Bank Guaranty(BG)/FDR (valid for 30 months) of Rs. 50,000/- (Fifty Thousand) only in Favor of "Project Director, BLDA, Patna Payable at SBI Branch Bihar Vet College Campus (IFSC Code- SBIN0009006), Patna-14
- 15. Successful bidders must start working immediately after the work order is given.

- 16. The successful bidder will have to execute an agreement on the Indian non-judicial stamp paper of Rs. 1000/- (One Thousand) only of appropriate denomination (which would be borne by the tenderer) as stipulated by the state Govt. of Bihar.
- 17. Time-to-time work orders will be released according to the need.
- 18. Terms of Payment: BLDA will release unit-wise full payment after deducting mandatory taxes as per the law within 30 days of completion of the work subject to the availability of the fund and physical verification/production of a certificate of work completion with the valid bill.
