1. National Insurance Co. Ltd., hereinafter called 'NIC', invites bids from eligible vendors for procurement of Contract for Scanning of documents/images and Uploading and restoring the scanned images/metadata to the Server/Storage to be provided by NIC.

2. The vendor shall be responsible for providing all types of services as mentioned in Tender document and Scope of Work.

## Details are as follows:

- The offer shall be given in a sealed Covers, by marking "Quotation for procurement of Contract for Scanning of documents/images and Uploading and restoring scanned images/metadata".
- The documents should be signed by the authorized official of the vendor.
- It will be a single packet bid.
- Commercial Bid will be considered only when the Eligibility criteria (Refer Point no.1 of Terms and Conditions) is met or else commercial bid shall not be considered.
- Any bid incomplete in any respect will not be considered and shall be rejected.

### TERMS AND CONDITIONS OF THE TENDER

## 1. Technical Eligibility Criteria:

- a) The bidder must be empanelled vendor of NIC HO for small IT purchases.
- b) The bidder must have an office in Kolkata.
- c) The scanning should be done through Color Scanner and the scanned output should be of very high quality, acceptable readability, reasonable accuracy, consistent in term of tone and color reproduction.
- d) The scanner output should have minimum of 200 dpi.
- e) Basic image enhancement, De-skew, De-Speckle Cropping & hole removal etc., to be carried out on all images for optimum image clarity without compromising the quality of text, photographs etc.
- f) The selected Vendor will capture data (text, photographs etc.) from the documents as provided by the Pension Department of NIC and create PDF images. The final scanned copy in PDF should be legible, with completeness, image quality (tonality and color), and the ability to reproduce pages in their correct (original) sequence.
- g) Vendor will develop the structured PDF file along with embedded metadata by tagging them.
- h) The digitized images to be converted to searchable PDF format. The layout of the page should be retained.

- i) Selected Vendor will ensure data integrity. No page/part of documents will be left unscanned. The vendor will recoup the missing pages/parts, if any, at its own cost. In other words, the vendor will ensure that the entire document from the cover page to the last page is captured.
- j) A file-naming scheme database should be established prior to capture. The same will be provided by the Pension Department of NIC.
- k) The vendor has to submit the declaration of Conflict of interest as per **Annexure B** at the time of submission of the Bid.
- I) The vendor has to submit the declaration on Data security and non-misuse of data in their Letter Head with sign and seal by the authorized official of the vendor.
- m) Vendor needs to submit EMD of Rs. 30,000/- while submitting the bid in favor of NIC in the form of DD/NEFT mentioned Bank Account:

- Non-furnishing of Earnest Money Deposit along with the bid will disqualify the Bidder and his bids will not be entertained.

- For the successful Bidder the EMD amount, without any interest, will be refunded on completion of contract period. This RFP Document is not transferable.

Exemption from payment of EMD (Earnest Money Deposit) and Tender Fee.

Note: Only Micro and Small Enterprises (MSEs) as defined in MSE Procurement Policy issued by department of Micro, Small and Medium Enterprises (MSME) are exempt from submission of EMD (Bid Security) and tender fees. Bidders claiming exemption of EMD under this rule (170 of GFR) are however required to submit a signed Bid securing declaration accepting that if they withdraw or modify their Bids during the period of validity, or if they are awarded the contract and they fail to sign the contract, or to submit a performance security before the deadline defined in the request for bids document, they will be suspended for the period of 12 months from being eligible to submit bids. Non submission against the same at Pre-qualification stage, will disqualify the bidder. Certificate needs to be produced.

## 2. Scope of work:

- 1. Scanning of 16000 pension files with 30-35 Pages (both sides) per file approx.
- 2. Merging of new documents in existing files by scanning in searchable pdf format and uploading the same in the file already created.
- 3. Delivery timeline for scanning the above documents: 60 days from date of Purchase Order.
- 4. Scanned documents to be stored in separate folders with different kinds of searching mechanism for searching the pensioner's details from the **files/metadata**.
- 5. Documents to be scanned are in A4 size in searchable pdf format.
- 6. Data needs to be stored in server/storage which will be provided by NIC. Vendor needs to take responsibility to restore the data as and when required.
- 7. During contract period, vendor will have to scan additional documents and restore the same as and when provided by NIC.
- 8. NIC will provide 3 nos. of systems, office space and power. However, Scanner and manpower needs to be provided by bidder.
