Commodity EXIM Report **DGCI & S, I T J Division**

The weekly EXIM Report published by ITJ Division of DGCI&S, Kolkata presents some basic insights into India's export and import trade patterns w.r.t. selected set of commodities identified each week in order to facilitate preliminary commodity group/sector specific analysis for better policy making.

2. For both categories of trades, one commodity group is chosen from the entire ITC-HS 4-digit Classification (latest being 2023-2024 classification system). The Indian Trade Classification based on Harmonized System has been adopted in India for Export and Import Operations. While India specific data is sourced from DGCI&S, M/o C & I Database, global export-import data of exactly those sets of commodities are sourced from UN-Comtrade Database.

3. As regards the time-period, this report outlines trade statistics over a period of four years. Currently (for reports being prepared in FY 2023- 2024) we are considering the time-period of 2020-2021 to 2023-2024(Financial year data). The latest finalized data available on the UN Comtrade Database is only up to year 2023 (Calendar Year) and on the DGCI&S Database up to June, 2024. So, for each commodity group dealt in this report, trends from 2020 to 2023 have been showcased where data has been sourced from UN Comtrade and from 2020-2021 to 2023-2024 when sourced from DGCI&S database; however, for computation of commodity group's share in India's overall export basket and import basket we have had to use FY (financial year) data as all aggregate level data in India are represented in FY format.

4. In the instant report [1st weekly Commodity Exim Report of July,2024 dated 3rd July, 2024] the following two commodities have been dealt with.

Export : Telephone Sets, Smart Phones and other Telephones for cellular Networks or for other Wireless Net Works [ITCHS Code –8517] -In FY 2023-2024 (April,2023 –March,2024) this commodity group has 3.89% share in India's total Export value basket as per DGCI&S data base. India had occupied the 7th slot in export of this commodity (15646.43 million USD) with 3.32% share of total global exports in the year 2023.

Import : Microphones, stands, Loudspeaker, Headphones etc. [ITCHS Code – 8518] –In FY 2023-24 (April 2023 – March,2024) this commodity group had share of 0.26% in India's total Import value basket as per DGCI&S data base. India having 3.88% share of total global imports of this commodity (1757.72 million USD) occupied the 6th slot in the world in 2023.

EXPORT

Telephone Sets, Smart Phones and other Telephones for cellular Networks or for other Wireless Net Works classified as H.S. Code – 8517 alls under Chapter -85 (Electrical Machinery and Equipment and Parts thereof; Sound and TV Recorders and Reproducers and Parts thereof) of Section XVI concerning Machinery and Their Parts, Electrical and Electronic Equipment, Parts thereof of ITC-HS classification.

India is engaged in the process of exporting this commodity and in 2023-2024 FY this commodity group has so far had 3.32% share in India's total Export value basket as per DGCI&S data base.

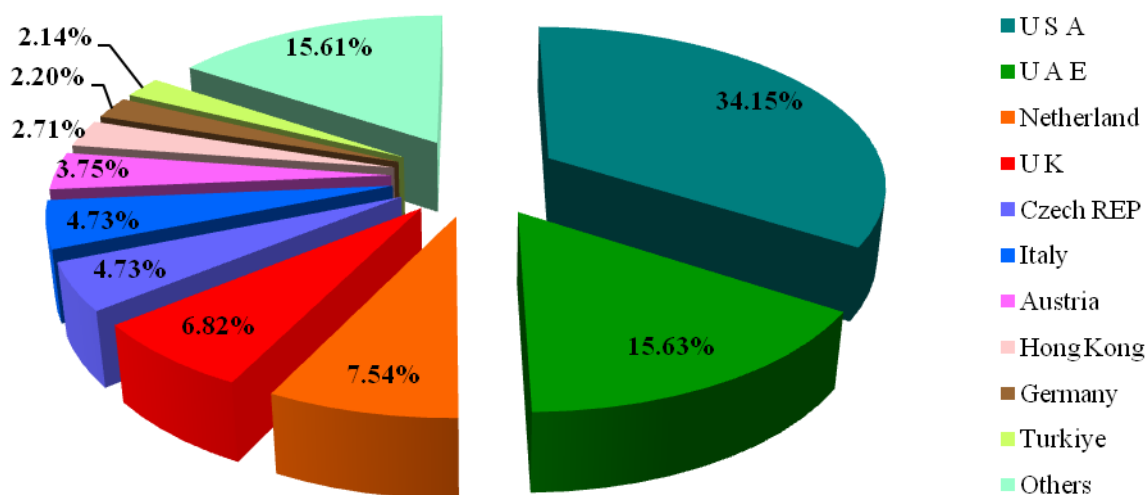

India's top 10 destinations of Telephones including Mobile phones by percentage share in 2023-2024



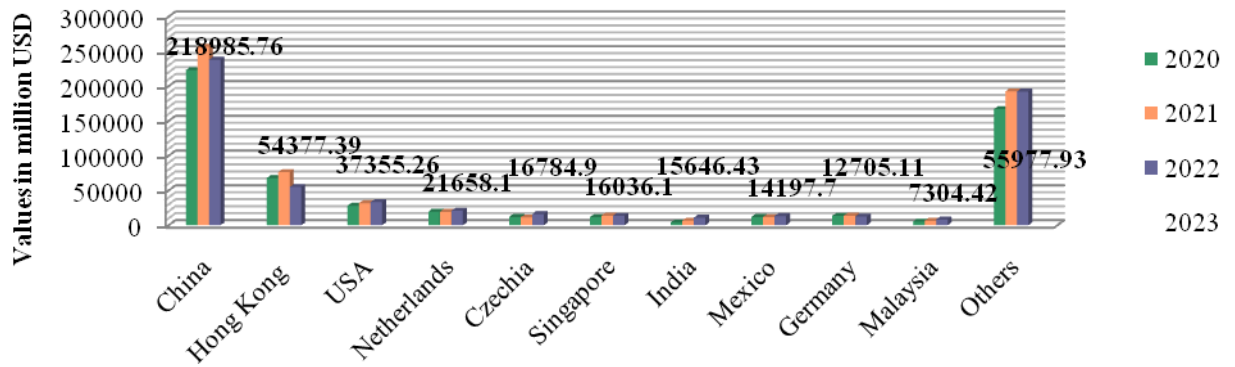
In the year 2023-2024 India has exported Telephones including Mobile phones worth of US \$ 16999.38 million and registered an increase of 34.54% million compared to overall 2022-2023 figures of US \$ 12634.34 million. Over the period under review the exports of this segment were at record high at US \$ million in 2023-2024. USA (USD 5804.56 million) has held the top slot as an export destination in this segment from India with 34.15% share of India's total export of the commodity in 2023-2024 followed by UAE (USD 2656.88 million) and Netherland (USD 1282.29 million) with 15.63% and 7.54% shares respectively. Over the period under review India's exports in this segment has steadily been rising from 2020-2021 till 2023-2024 with a major leap in 2022-2023.

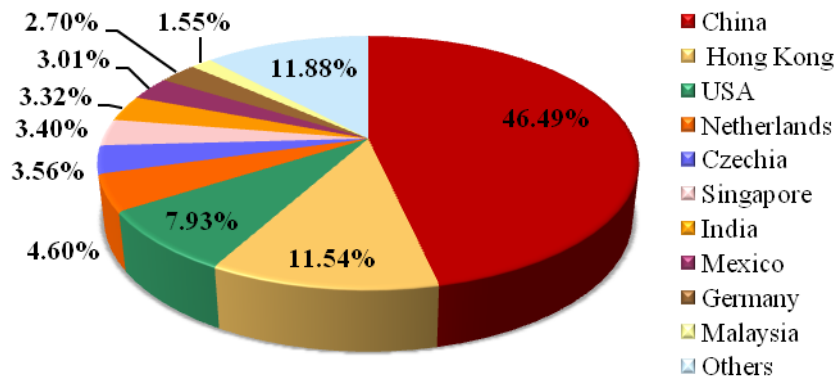

World's 10 leading exporters of Telephones including Mobile phones (percentage share in 2023):



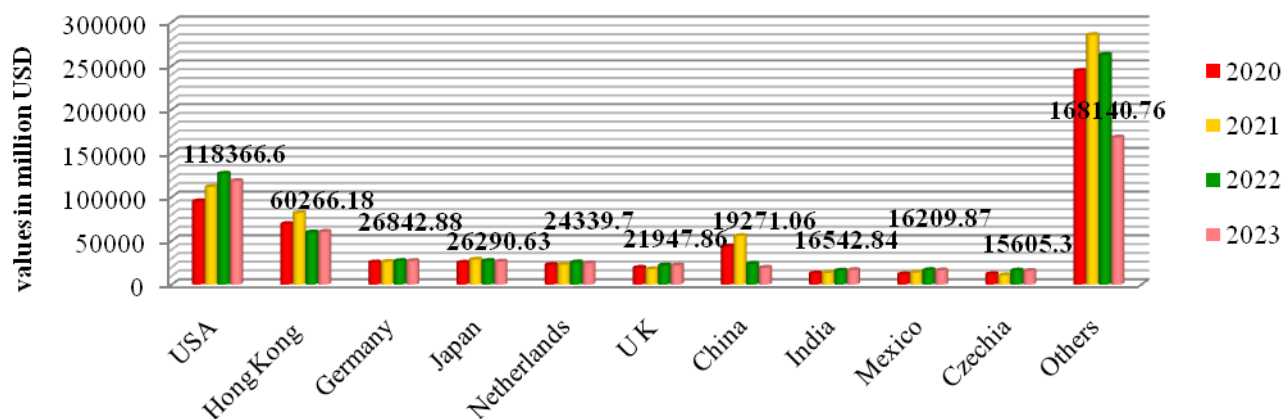
The global Telephones including Mobile phones exports was US \$ 471029.10 million in 2023, decreasing by 23.33% over the previous year. China (US \$ 218985.76 million) occupied the top slot in this segment with the highest level of exports recorded in 2023 with 46.49% shares of global exports followed by Hong Kong (US\$ 54377.39 million) and USA (US\$37355.26 million) with 11.54% and 7.93% share of global exports of these commodities in 2023 respectively. **India** (exporting goods worth a total of US\$ 15646.43 million in this category) with a show of 3.32% share, stood at 7th position in the world in 2023. India's share in global exports of this commodity group has gradually been rising.

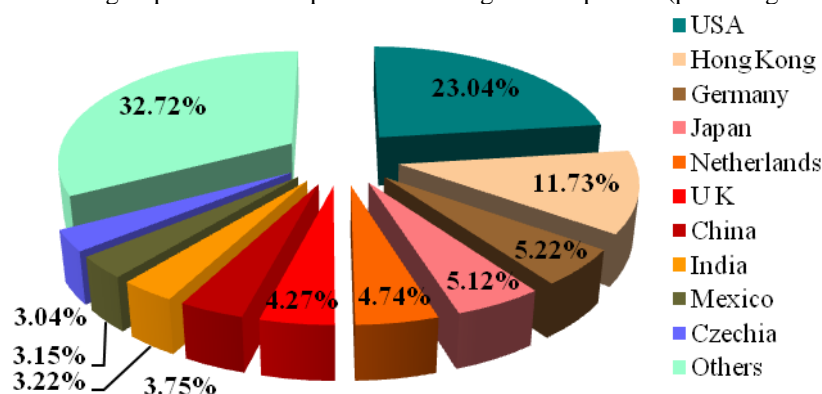

World's 10 leading importers of Telephones including Mobile phones (percentage share in 2023)



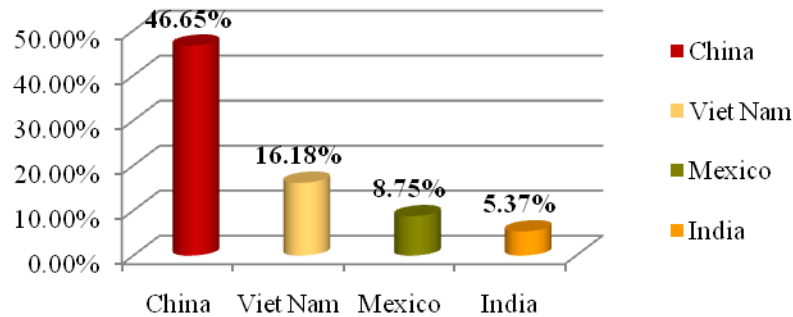
The Telephones including Mobile phones imports worldwide was US\$ **513823.67** million in 2023, decreasing by 17.41 % from 2022 levels. The lead importers in this segment in 2023 have been USA (23.04%), Hong Kong (11.73%), and Germany (5.22 %) and **India** has occupied the 8th position by way of importing up to 3.22% of global imports of this segment. Quite strikingly on one hand India is the 8th largest importers of this product and on the other hand India is the 7th largest exporter of Telephones including Mobile phones in the world .

Note: Additionally from UN Comtrade data base it is observed that there exists a difference of US\$ 42794.57 million between world exports and world imports this segment in 2023.

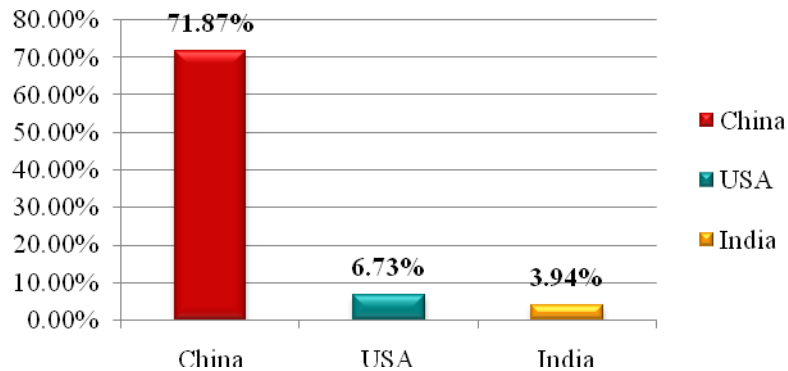
As per UN Comtrade database in 2023 the top 3 importers of **Telephones including Mobile phones** globally were **USA, Hong Kong and Germany**.

These 3 Country have imported 5.37%, 3.94% and 2.30% share of their total import of Telephones including Mobile phones from India in 2023 respectively which are represented below:

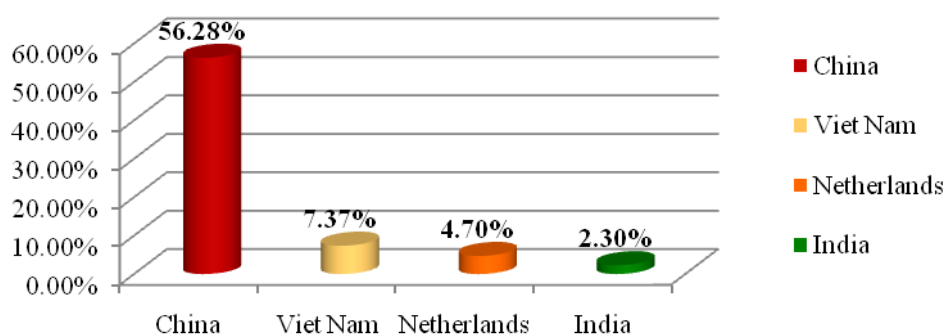
i) Top 3 supplier nations of Telephones including Mobile phones to USA in 2023 (percentage share):

India is engaged in the process of importing this commodity and in the FY 2023-2024 this commodity group had share of 0.26% in India's total Import value basket as per DGCI&S data base

In 2023-2024 India had imported a total of USD 1747.04 million worth of Microphones, stands, Loudspeaker, Headphones etc.. As per available data, China stood out as India's top importing partner in this segment with a share of 56.17% registering a considerable leap over the 2022-2023 levels. Next in line comes Vietnam and Hong Kong with very limited shares of 16.71% and 11.78% respectively. India's import value in this segment has been gradually increasing till 2022-23.

Worldwide import of Microphones, stands, Loudspeaker, Headphones etc. only totalled to US\$ 45338.29 million in 2023 recording a 15.70% down over 2022 levels. USA imported US\$ 12405.08 million worth of the commodity in 2023, making it the leading importer of the commodity group worldwide with 27.36 % share of world imports. Germany (8.19%) and China (6.09%) lined up in second and third place in 2023. The import value of Microphones, stands, Loudspeaker, Headphones etc. in **India** amounted to approximately US \$ 1757.72 million in the year 2023 and **India** ranked 6th in the world with the share of 3.38% of total global import value of goods in this segment experiencing a leap from US \$1685.45 million in 2022 to 1757.72 million.
