## Commodity EXIM Report DGCI & S, I T J Division

The weekly EXIM Report published by ITJ Division of DGCI&S, Kolkata presents some basic insights into India's export and import trade patterns w.r.t. selected set of commodities identified each week in order to facilitate preliminary commodity group/sector specific analysis for better policy making.

2. For both categories of trades, one commodity group is chosen from the entire ITC-HS 4-digit Classification (latest being 2023-2024 classification system). The Indian Trade Classification based on Harmonized System has been adopted in India for Export and Import Operations. While India specific data is sourced from DGCI&S, M/o C & I Database, global export-import data of exactly those sets of commodities are sourced from UN-Comtrade Database.

3. As regards the time-period, this report outlines trade statistics over a period of four years. Currently (for reports being prepared in FY 2023- 2024) we are considering the time-period of 2020-2021 to 2023-2024(Financial year data). The latest finalized data available on the UN Comtrade Database is only up to year 2023 (Calendar Year) and on the DGCI&S Database up to July,2024. So, for each commodity group dealt in this report, trends from 2020 to 2023 have been showcased where data has been sourced from UN Comtrade and from 2020-2021 to 2023-2024 when sourced from DGCI&S database; however, for computation of commodity group's share in India's overall export basket and import basket we have had to use FY (financial year) data as all aggregate level data in India are represented in FY format.

4. In the instant report [3<sup>rd</sup> weekly Commodity Exim Report of September,2024 dated 18<sup>th</sup> September, 2024] the following two commodities have been dealt with.

**Export: Structures and Parts of Structures [ITCHS Code –7308]** - In FY 2023-2024 this commodity group has 0.40% share in India's total Export value basket as per DGCI&S data base. India had occupied the 3<sup>rd</sup> slot in export of this commodity (1735.43 million USD) with 2.69% share of total global exports in the year 2023.

**Import : Instruments and Appliances used in Medical, Surgical, Dental or Veterinary Sciences. [ITCHS Code – 9018 ] –** In FY 2023-24 (April 2023 – March, 2024) this commodity group had share of 0.38% in India's total Import value basket as per DGCI&S data base. India having 1.69% share of total global imports of this commodity (2516.36 million USD) occupied the 14<sup>th</sup> slot in the world in 2023.

#### **EXPORT**

**Structures and Parts of Structures** classified as H.S. Code – 7308 falls under Chapter -73 (Articles of iron or steel) of Section XV (Base Metals and Articles of Base Metal) of ITC-HS classification. India is engaged in the process of exporting this commodity and in 2023-2024 FY this commodity group has so far had 0.40% share in India's total Export value basket as per DGCI&S data base.



The total export value of Structures and Parts of Structures from India amounted to US\$ 1754.88 million in 2023-2024 and registered an increase of 3% compared to the year 2022-2023 figures of US\$ 1703.71 million. For, the period under review, exports of this segment were at US\$ 1059.82 in 2020-2021 followed by a moderate rise till 2023-2024. USA(US\$ 703.91 million) has held the top slot as an export destination in this segment from India with 40.11% share of India's total export followed distantly by Saudi Arab(US\$ 98.27 million) and UAE (US\$ 77.34) to where India exported around 5.60% and 4.41% share of total export of Structures and Parts of Structures respectively in 2023. USA has persistently been lead consumer of our products in this segment.




 World's Top 10 exporters of Structures and Parts of Structures (HS Code – 7308)

World's 10 leading exporters of Structures and Parts of Structures by Percentage share in 2023




The global exports of Structures and Parts of Structures worldwide amounted to US\$ 64429.70 million in 2023, decreasing by 4.45% over the previous year. The lead Exporter in this segment has consistently been China (exporting goods worth a total of US \$ 19782.50 million) with a show of 30.70% share in 2023, Germany (US\$ 5241.21 million) and Poland (US\$ 3954.99 million) with 8.13% and 6.14% share of world exports in this segment in 2023 stood at 2<sup>nd</sup> and 3<sup>rd</sup> slots respectively. **India** (exporting goods worth a total of US \$ 1735.43 million) with a show of 2.69% share, stood at 11<sup>th</sup> slot in 2023 of world export Structures and Parts of Structures. India's export value in this segment had continuously positive trend till 2023.




 World's top 10 Importers of Structures and Parts of Structures (HS Code – 7308)


World's 10 leading importers of Structures and Parts of Structures (Percentage share in 2023)




The Structures and Parts of Structures imports worldwide was US\$ 50371.74 million in 2023, decreasing by 10.90% from 2022 levels. The lead importers in this segment in 2023 have been USA (17.03%), Germany (9.12%), and France (5.08%). **India** with a show of 057% share in this category, stood at 36<sup>th</sup> position globally. Global imports in this segment had increased from 2020 till 2022 with a major leap in 2021 and followed dip in 2023.

As per UN Comtrade data base the top 3 importers of Structures and Parts of Structures globally were **USA**, **Germany and France**. USA, Germany and France had imported 8.35%, 0.67% and 0.41% share of their total imports of Structures and Parts of Structures from India in 2023 which are presented below.


(i) Top 3 supplier nations of Structures and Parts of Structures to USA in 2023 (percentage share)

**Instruments and Appliances used in Medical, Surgical, Dental or Veterinary Sciences [ ITCHS Code – 9018**] falls under Chapter -90 (Optical, photographic, cinematographic, measuring, checking, precision, medical or surgical instruments and apparatus; parts and accessories thereof) of Section – XVIII (Optical, Photographic, Cinematographic, Measuring, Checking, Precision, Medical or Surgical Instruments and Apparatus; Clocks and Watches; Musical Instrument; Parts and Accessories Thereof ) of ITC-HS Classification.

India is engaged in the process of importing this commodity and in the FY 2023-2024 this commodity group had share of 0.38% in India's total Import value basket as per DGCI&S data base

In 2023-24 India had imported a total of USD 2584.82 million worth of Instruments and Appliances used in Medical, Surgical, Dental or Veterinary Sciences. As per available data, USA stood out as India's top importing partner in this segment with a share of 21.38%. Followed by China and next Germany with shares of 17.24% and 10.68% respectively. India's import value in this segment had a huge jump in 2021-2022 over 2020-2021 with a continuing trend till 2023-2024.

Worldwide import of Instruments and Appliances used in Medical, Surgical, Dental or Veterinary Sciences totalled to US\$ 149026.08 million in 2023 recording a 2.32% declining over 2022 levels. USA imported US\$ 37909.23 million worth of the commodity in 2023, making it the leading importer of the commodity group worldwide with a whopping 25.44 % share of world imports. Netherlands (9.17%) and Germany (8.78%) lined up in second and third place in 2023. **India** amounted to approximately US \$ 2516.36 million in the year 2023 and **India** ranked 14<sup>th</sup> in the world import of this commodity with the share of 1.69% of total global import value of goods in this segment.
