In case the lowest bidder fails to produce the original documents for entering into an agreement or the original documents submitted does not match with the uploaded documents or found false ,then his bid is treated as non-responsive bid as per clause -26(4) of the KTPP rules barred from participation in any of the tenders invited by the apart from forfeiting the EMD paid through E-cash.

 - 2.2 First Electronic Document (Technical BID) will be opened on 16-11-2022 at 5.00 PM in the Presence of the Bidders who wish to participate.
 - 2.3 Second Electronic Document (financial Bid) of the successful bidders who qualify in the technical bid will be opened after approval to the technical bid on 23-11-2022 at 11.00 AM from the competent authority.
 - 2.4 The necessary certificates/documents in support of qualification criteria fulfilled as stipulated shall be scanned and attached to e-tender document.
 - 2.5 The scanned signature of the bidder /authorized representatives of the bidder shall be attached while uploading the bid document.

- 3.0 Qualification Criteria: (for Individual bidders/ Joint Venture Bidding).
- (A) Eligible Criteria
 - i. The intending bidders should be a registered contractor enrolled in valid KPWD Class-I
 - ii. The requisite Earnest Money Deposit (e-cash)
 - iii. Valid Employees Provident Fund Registration Certificate.
 - iv. Valid GST Registration Certificate mandatory

Note:-

- a) The Successful bidder shall furnish within 15 days from issue of letter of intent before entering in to agreement, a Copy of Income Tax returns filed mentioning PAN for the financial year 2021-22 (Assessment year 2022-23) prior to date of entering in to the agreement. Failing which the EMD amount will be forfeited and the tender will be rejected and the bidder shall be liable for subsequent penal action including black listing.
- b) The amount put to tender is exclusive of GST and the tenderer should quote without GST. However G.S.T will be paid at prevailing rate during billing.

(B) QualificationCriteria

- a. The intending bidder should have in last 5 years i.e. from 2017-18 to 2021-22, satisfactorily completed (not less than 90% of contract value) as a prime contractor, one similar work costing not less than Rs. 80.80 Crores. The work done certificate should be obtained duly signed from an officer not below the rank of Executive Engineer of the concerned Division and counter signed by the Superintending Engineer of the same circle or equivalent in case of other Government undertaking within India. The cost will be updated to the present value by giving a weight age of 10% for each year, if the work is completed prior to FY 2021-22.
- Note-:1) Similar work means the work should comprise of lift irrigation / water supply scheme involving lift components such as intake Arrangement, Jackwell / sump, pump house, MS rising Main, Pressure / Gravity Distribution system, Electro Mechanical works, Delivery Mechanism (Delivery Chamber / Sump) with all arrangements.

b. The intending bidder in his / its name should have in the last 5 years i.e., 2017-18 to 2021-22 achieved in at least 2 financial years, a minimum financial turnover of Rs. 215.47

Crores. (Rs. 161.60 Crores x 2 x 12 months / 18 months). The turnover prior to FY 2021-22 will be updated to the Present Price Level (*) by giving weight age of 10% each year. Audited Profit and Loss account certified by a practicing Chartered Accountant bearing UDIN along with copy of Income Tax returns filed for the years indicated above should be furnished.

(*) FY2021-22.

- c. Tendering by a joint venture is permissible with maximum of two partners subject to the following conditions
- i. The joint venture shall be performed prior to the tendering and blank tender forms shall have been purchased by the joint venture itself
- Enrollment of partner of the joint venture shall have been registered contractor enrolled in KPWD-Class-I.
- iii. One of the partners of JV (Lead Partner) shall be duly authorized with a legally binding power of attorney to apply for tender forms and to sign the tender and to make further correspondences and deal with KBJNL on behalf of JV
- iv. A contractor is not eligible to participate as partner of more than one JV
- v. In case of JV all the partner are jointly and severally responsible for successful performance of the contract
- vi. The lead partner shall enter in to a joint venture agreement on Rs. 500 stamp Paper in the prescribed format which shall be concluded prior to bidding and enclosed to the bid document and submit along with the request for bid document.
- d. The qualification criteria can be satisfied by individually or JV (adding collectively the credentials of all JV partners). All the partners should have achieved at least 25% of prescribed annual turnover (Prequalification criteria), in any of the 2 financial years during the last 5 years (i.e., 2017-18 to 2021-22). Audited Profit and Loss account settlement certified by a practicing Chartered Accountant bearing the UDI Number along with copy of income Tax returns filed for the years indicated above should be furnished. Charted accountants certificate without UDI (Unique document identification) Number will not be considered.
- e. The intending bidder should have laid and tested minimum quantity of MS Rising Pressure pipe system of the work with following diameter of pipes in any one financial year, during the last five financial years reckoned back from 2021-22. Certificate should be obtained from an officer not below the rank of Executive Engineer of the

concerned Division and countersigned by the SE of the concerned Circle or equivalent in case of other Govt. undertaking within India.

- i. MS pipe with Inner diameter 300 mm and above for length 50.00 Km for MS Rising Pressure distribution system. 80% of the peak annual rate of construction / tender period ((0.8X 93.04 KM X12)/18).
- f. The intending bidder should have supplied, installed, commissioned and maintained at least 2 Nos. of VT Pumps and Motors of capacity not less than 1190 HP and should have minimum one year of experience in Operation and Maintenance. The certificate should be issued by an officer not below the rank of Executive Engineer of the concerned Division / Equivalent officer and countersigned by the SE of the concerned Circle / next higher officer.
- g. The intending bidder should have executed / (*) got executed through reputed CEIG Registered electrical contractor not less than 5 MVA Transformer and 33 KV substation for Power Transmission line work for a minimum length of 6.00 Km (10*0.80*12 months / 18 months) (80 % of the peak annual rate of construction) with 33 KV Terminal Bay in any one financial year during the last 5 years (i.e., 2017-18 to 2021-22). The work done certificate should be obtained duly signed from an officer not below the rank of Executive Engineer of the concerned Division and counter signed by the Superintending Engineer of the same circle or equivalent in case of other Government undertaking.
- (*) Note-: 1) If the bidder has not executed the Transmission line work / Sub-station work, he should execute the work through reputed CEIG registered electrical contractor who has Completed 5 MVA transformer, 33 KV Sub station To this effect a certificate / declaration shall be furnished in the Technical bid.
 - 2) The successful bidder should furnish documents in support of the work done by CEIG registered electrical contractor at the time of concluding the agreement for the work. After getting approval from the Chief Engineer, the transmission line work shall be carried through the CEIG registered Electrical Contractor.

h. Notes to the bidders on PQ:

- The intending bidder should furnish data sheets for technical parameters of pumps, motor, transformers and other details sought under Section 14 Data sheets of the bid document.
- The bid evaluation of electro mechanical works will be done as per Section 8 Contract Data Clause No.20 bid evaluation factors.

- iii. Bids not satisfying minimum duty point parameters, efficiency parameters of pumps and motors and velocity parameters as specified in bid document shall be rejected.
- iv. No credit will be given during bid evaluation, if parameters higher than those specified in the Bid document- Section 8 scope of work (in terms of duty point parameters, efficiency parameters of pumps and motors and velocity parameters) are offered by the bidder.
- v. The successful bidder shall submit the tie up agreement at the time of concluding the agreement for the work in the format prescribed in the bid document, failing which the EMD amount will be forfeited and contract will be rescinded at his risk and cost and liable for penal action including black listing. If one of the JV is pump manufacturer then tie up with pump manufacturer is not necessary.
- vi. The tie up arrangement will be generally permitted with the pump manufacturer whose data parameters are uploaded and in conformity with the details submitted in the data sheet of the bid document at the time of bidding. However, the successful bidder will be permitted to have tie up agreement with other pump manufacturer provided his data parameters are unaltered with the uploaded parameters.
- vii. During technical evaluation KBJNL find that any certification / information is false, such bidders will be disqualified and barred from participation in the bid their EMD will be forfeited.

If any bidder fails to satisfy the conditions mentioned above, such bids will be rejected.

i. Bid capacity:- Tenderers who meet the above specified minimum qualification criteria, will only be qualified, if their available tender capacity is more than the total tender value (Rs.Lakhs).

The available tender Capacity will be calculated as under:

Assessed available tender Capacity = (A*N*1.5 - B),

where,

A = Maximum value of civil engineering works Executed in any one year during the last five years (updated to 2021-22 price level) taking into account the completed as well as works in progress.

N = Number of years prescribed for completion of the works for which tenders are invited.

B = Value, at 2021-22 price level, of existing commitments and on-going works to be completed during the next 18 months (Period of completion of the works for which tenders are invited)

Note:-1: The statements showing the value of existing commitments and on-going works as well as the stipulated period of completion remaining for each of the works listed should be certified by Statutory Auditors of the Company or by the proprietor of the company through an affidavit.

Note:-2: Even though the Tenderers meet the above criteria they are subject to be disqualified if they have:

- (a) made misleading or false representation in the forms, statements and attachments submitted in proof of the qualification requirements and / or
- (b) record of poor performance such as abandoning the works, not properly completing the contract, inordinate delays in completion, litigation history or financial failure etc, and / or
- (c) Participated in the previous tender for the same work and had quoted unreasonably high tender prices and could not furnish rational justification.

If the bidder / bidders have participated in more than one work, the available tender capacity will be assessed and number of works will be awarded as per his available bid capacity.

- j. Each bidder should furnish liquid assets and/or availability of credit facilities of not less than Rs. 27.00 Crores from any Nationalised/scheduled bank [Credit lines/letter of credit/certificates from banks for meeting the fund requirement etc. (Usually the equivalent of the estimated cash flow for 3 months in the peak construction period)]. The format for bankers certificate/line of credit (BC/LOC) letter to be issued by the Banks as per circular No. FD-CAAM/16/2022 (P-2) Dated: 22-08-2022.
- k. Intending bidders should have own / lease equipments and machineries shall be furnished as per the Finance Department (Govt) Circular No. FD 263 / EXP/12/2022, dated: 11-05-2022.

4.0 The intending bidders shall submit bids as an Individual bidder along with Tie up of pump manufacturer. The Tie up is to be formed prior to the bidding.

However, tenders from a Tie up proposed in this bid, the bidder shall upload an agreement with only one pump manufactures on Rs. 200.00 stamp paper in the prescribed format which shall be concluded prior to bidding and enclosed to the bid document. For proof of the Tie up in the Technical bid in the prescribed format under section 2 of instruction to bidder (multiple tie up not allowed).

The First Electronic Document (Technical bid) will be opened first and thereafter Second Electronic Document (financial bid) will be opened only of those bidders who qualify in the technical bid. In case the lowest bidder fails to produce the original documents for entering into an agreement or the original documents submitted does not match with the uploaded documents or found false, then his bid is treated as non-responsive bid as per clause 26(4)of the KTPP rules & his name would be removed from the select list of KBJNL enrolment and barred from participation in any of the tenders invited by the KBJNL apart from forfeiting the EMD paid through E cash.

Each Tenderer should further demonstrate:

Availability by owning 50% of the required/specified flowing key and critical equipment for this work and the remaining 50% can be deployed on lease/hire basis for all works provided, the relevant documents (Commitment agreements etc.) for availability for the work are furnished (Documents to be scanned and enclosed)The intending bidder/firm/company/Joint venture should furnish details of ownership/ lease certificate of the following minimum requirement of machineries.

- In the case of the death of the contractor after executing the agreement / commencement of the work, his legal heir, if is an eligible registered contractor and is willing can execute and complete the work at the accepted tender rates irrespective of the cost of the work.
- Necessary work experience certificate issued by the competent authority not below the rank of Executive Engineer, indicating the name/items of work executed, date of

commencement, date of completion and the total cost of work executed shall be enclosed to the tender. Tenders without these details are liable for disqualification.

5.0 General Conditions:

- 1 The bid shall be technically evaluated based on the specifications indicated in Section-5 titled "Contract Data and Scope of work" in bid document.
- The Bidder/JV partner/ Tie up partner shall not be under Corporate Debt Restructuring (CDR) / Strategic Debt Restructuring (SDR) or Bureau of Industrial and Financial Reconstruction (BIFR) in the last 5 Years prior to bid submission date. In this regard, the Bidder shall submit along with Bid, a certificate from their Statutory Auditor with a declaration that, the Bidder is not under CDR / SDR or BIFR.
- 3 Bids not satisfying minimum duty point parameters, efficiency parameters of pumps and motors and velocity parameters as specified in bid document shall be rejected.
- 4 During technical evaluation, if the employer finds that any certificates / information furnished is false, such bidders will be disqualified and barred from participation in the bid.
- If any bidder fails to satisfy the conditions mentioned above, such bids will be rejected and their financial bids will not be opened.
- 6 For laying M.S. pipe line the contractor shall engage only those agencies who have done similar job.
- 7 The bidder should enclose the detailed methodology of execution of the scheme as per the scope of work.
- 8 The Bidder shall be responsible for successful performance of the contract
- 9 For construction of Transmission line/Substation Works, the contractor shall engage only those agencies who are licensed to do the power line construction works in Karnataka. They should have constructed at least one similar single power line equal to 80% of the length of power line for the work tendered in a single contract. The details of the transmission line construction contractor with registration certificate and certificates of experience signed by an officer of not below the rank of Executive Engineer of KPTCL shall be submitted for KBJNLs verification post award of the work.

- 10 The Bidder to participate in the tender under single bid basis only. Any violation will attract disqualification of the bid.
- 11 The pump manufacturer shall not enter into Tie-up with more than one bidder.
- 12 The contractor/authorized signatory should attach his/her scanned signature to the Schedule-B before uploading and also submitting their tenders.
- 13 If any of the dates mentioned above happen to be a general holiday, the next working day holds good.
- 14 The work of the construction of transmission line should be got done through a Government Licensed, Super Grade Electrical contractor CEIG approved, who have the experience of carrying out such works.
- 15 The diameters of the rising main and thickness of the rising main shall not be less than the figures indicated in the enclosed schematic diagram. Further any discrepancies in the above shall not account to financial implications to the employer.
- 16 Further information can be had from the undersigned during office hours.
- 17 Conditional tenders are liable to be rejected. The officer competent to accept the tender shall have the right to reject any or all the tenders without assigning any reason whatsoever.
- 18 Corrigendum will be published in the web site/ newspapers of all modifications /corrections if any.
- The intending bidders should note that, if any of lands either in part/ parts or in whole required for the work is not acquired by the Nigam, it shall be the responsibility of the bidder to take the possession of such land and start the work by obtaining consent of the land owners before commencement of work at no extra cost to the Nigam and no claim / delays whatsoever relating to on account of non-availability of land would be entertained.
- 20 If the percentage quoted by the contractor for the work is below ninety percent of the updated recast estimated amount put to tender, then the contractor shall furnish an additional performance security in the form of Bank Guarantee for an amount equivalent to the difference between the cost as per quoted percentage and 90% of the

updated cost put to tender. In case of contractor quoting above 125% of updated cost put to tender, then the over and above 125% of the updated cost put to tender will be withheld during the progress of work. The additional performance will be released proportionately to the bill amount till the contractor achieves progress of the entire cost of the work as per agreement. The withheld amount in the later case will be released only after entire work contracted is fully completed and so certified by the Executive Engineer. (If BG submitted while issuing fresh BG or extending any existing BG, claim period of a minimum one year from the date of expiry of validity period of BG is to be specified invariably)
