Bidder should have an annual turnover of not less than Rs.15 Cr for at least Three years during the last '5' years. The Bidder should enclose copies of the audited financial statements of the last '5' years so as to prove the financial capacity of the bidder to execute the order.

- 3.0 The Bidder should have a valid EPF & ESI registration numbers and Labour license and shall furnish copies of proof of payments/ remittances made during the past 2 years. They should not be defaulters in payments/ remittances.
- 4.0 The Bidder should have a valid GST registration number and shall furnish copies of GST returns filed during last two financial years. They should not be defaulters in payment of GST.
