Commodity EXIM Report DGCI & S, I T J Division

The weekly EXIM Report published by ITJ Division of DGCI&S, Kolkata presents some basic insights into India's export and import trade patterns w.r.t. selected set of commodities identified each week in order to facilitate preliminary commodity group/sector specific analysis for better policy making.

- 2. For both categories of trades, one commodity group is chosen from the entire ITC-HS 4-digit Classification (latest being 2023-2024 classification system). The Indian Trade Classification based on Harmonized System has been adopted in India for Export and Import Operations. While India specific data is sourced from DGCI&S, M/o C & I Database, global export-import data of exactly those sets of commodities are sourced from UN-COMTRDADE Database.
- 3. As regards the time-period, this report outlines trade statistics over a period of four years. Currently (for reports being prepared in FY 2023- 2024) we are considering the time-period of 2020-2021 to 2023-2024. The latest finalized data available on the UN Comtrade Database is only up to year 2023 (Calendar Year) and on the DGCI&S Database up to December,2024. So, for each commodity group dealt in this report, trends from 2020 to 2023 have been showcased where data has been sourced from UN Comtrade and from 2020-2021 to 2023-2024 when sourced from DGCI&S database; however, for computation of commodity group's share in India's overall export basket and import basket we have had to use FY (financial year) data as all aggregate level data in India are represented in FY format.
- 4. In the instant report [2nd weekly Commodity Exim Report of March,2025 dated 12thMarch 2025] the following two commodities have been dealt with.

Export : Furniture and Parts thereof. [ITCHS Code –9403] -In FY 2023-2024 this commodity group has 0.27% share in India's total Export value basket as per DGCI&S data base. India had occupied the 19th slot in export of this commodity (exported 1130.40million USD) with 1.15% share of total global exports in the year 2023.

Import: Saturated Acyclic Monocarboxylic Acids and their Anhydrides, Halides, Peroxides and Peroxyacids; their Halogenated, Sulphonated, Nitrated or Nitrosated Derivatives [ITCHS Code – 2915] – In FY 2023-24 this commodity group had share of 0.20% in India's total Import value basket as per DGCI&S data base. India having 8.83% share of total global imports of this commodity (1373.46 million USD) occupied the top slot in the world in 2023-2024.

EXPORT

Furniture and Parts thereof classified as H.S. Code – 9403 falls under Chapter -94 (Furniture; bedding, mattresses, mattress supports, cushions and similar stuffed furnishing; luminaires and lighting fittings, not elsewhere specified or included; illuminated signs, illuminated name- plates and the like; prefabricated building) of Section XX (Miscellaneous Manufactured Articles) of ITCHS classification.

India is engaged in the process of exporting this commodity and in 2023-2024 FY this commodity group had share of 0.27% in India's total Export value basket as per DGCI & S data base.



India's top 10 destinations of Furniture and Parts thereof Exports in 2023-2024 (Percentage share)




In the year 2023-2024 India has exported Furniture and Parts thereof worth of US\$ 1180.41million recorded an increasing little by 1.48% compared to 2022-2023 figures of US\$ 1163.20 million. USA (importing US\$ 561.95million worth of goods in this segment from India) has held the top slot as an export destination with 47.61% share of India's total exports, followed distantly by Netherland (US\$ 106.28million) and Germany (US\$ 83.75 million) to where India exported around 9% and 7.09% of the commodity respectively in 2023-2024. For, the period under review, exports of this commodity group were at US\$ 1038.53 million in 2020-2021 followed by persistent rise in2021-2022just after the pandemic period, a moderate dip in 2022-2023 followed by again a slight increase in 2023-2024.



The global export of Furniture and Parts thereof worldwide was US\$ 98033.53million in 2023 a declining by 12.20% from 2022 levels. China(exporting goods worth a total of US\$ 34400.16million in this category) with a show of 35.09% share, stood at top slot in 2023 of world export of 34400.16 globally, followed distantly next by Germany (US\$ 8894.06million) and Italy (US\$ 8287.35) with 9.07% and 8.45% share .India (exporting goods worth a total of US\$ 1130.40 million in this category) with a show of 1.15% share, stood at 19th slot in 2022 of world export of Furniture and Parts thereof. India's export value in this segment were at US\$ 909.08 million in 2020 and had major rise significantly in 2021 just after the pandemic year and then little declined in 2022 with an continuously negative trend till 2023.





Data labels signified for 2023




World's top 10 leading importers of Furniture and Parts thereof by percentage share in 2023




India occupied 35th Ranking w.r.t Furniture and Parts thereof imports worldwide was US\$ 431.45million in 2023, a little decreasing by 4.12% from 2022 level of US\$ 450.83 million. The lead importers globally in this segment in 2023 had been USA(30.21%) followed by Germany7.76%), and UK (5.76 %). Over the period under review, global import value was at US\$ 82318.03million in this segment in 2020 and continuous rising in 2021 and 2022, with a steep fall 2023. As per UN Comtrade database, a difference is observed between global exports and imports of Furniture and Parts thereof. In 2023 global exports exceeded global imports by US\$ 8177.40 million.

As per UN Comtrade date base the top 3 importers of Furniture and Parts thereof were **USA**, **Germany and UK**. USA, Germany and UK had imported 2.52%, 1.39% and 1.26% share of their total imports of Furniture and Parts thereof from India in 2023 which are presented below:


(i) Top 3 supplier nations of Furniture and Parts thereof to USA in 2023 (percentage share)

India is engaged in the process of importing this commodity and in 2023-2024 this commodity group had share of 0.20% in India's total import value basket.

The total amount of India's import of Saturated Acyclic Monocarboxylic Acids and their Anhydrides, Halides, Peroxides and Peroxyacids; their Halogenated, Sulphonated, Nitrated or Nitrosated Derivativesin 2023-2024 stood as US\$ 1366.68 million registering a 25.63% decreasing trends compare to the year 2022-2023 figures of US\$ 1837.59 million. In 2023-2024 China stood out as the top importing partner in this segment from where India has imported 40% share of its total import of Saturated Acyclic Monocarboxylic Acids and their Anhydrides, Halides, Peroxides and Peroxyacids; their Halogenated, Sulphonated, Nitrated or Nitrosated Derivatives, followed by Singapore(15.84%) and Malaysia (11.26%). Over the period under review India's import value in this segment huge jump in 2021-2022 over 2020-2021 and continuing negative trend in 2022-2023 and 2023-2024.

In 2023, the total global imports of Saturated Acyclic Monocarboxylic Acids and their Anhydrides, Halides, Peroxides and Peroxyacids; their Halogenated, Sulphonated, Nitrated or Nitrosated Derivativesamounted toUS \$ 15562.64 million, decreasing by more than 30.81% vis-à-vis the previous year's figure. **India** (importing goods worth a total of US\$ 1373.46 million in this category) with a show of 8.83% share, stood at top position, followed closely by Belgium (US\$ 1191.66 million) with 7.66% and Germany(US\$ 1151.34 million) with 7.40% share in 2023 respectively as per UN Comtrade Statistics.
