SECURITY DEPOSIT-CUM-PERFORMANCE GUARANTEE:

- (a) To ensure due performance of the contract, the Supplier/Contractor/Service provider receiving the LOA/PO/Work Order is required to furnish performance security at the rate 10 % of ordered value, in the prescribed form within 21 days after issuance of LOA for Works Contract or 14 days after issuance of PO/LOA for Goods/Services Contract.
- (b) In case of a JV, wherever applicable, the performance security shall be provided by all partners in proportion to their participation in the project.
- (c) Submission of Performance Security is not necessary for a contract value up to Rupees 1(one) lakh.
