**1. The RFP/Tender Document**

1.1. **E-NIT/E-Tender Inquiry**-This NIT is an integral part of the Tender document and serves a limited purpose of invitation, and does not purport to contain all relevant details for submission of bids. Bidders must go through the complete RFP/Tender Document for details before submission of their Bids. Contents/Provisions of RFP shall prevail in all circumstances.

1.2. **Availability of the RFP/Tender Document**- The RFP/Tender Document shall be published on the CWC's website [www.cewacor.nic.in](http://www.cewacor.nic.in) or e-tender website. It shall be available for download after the date and time of the start of availability till the deadline for availability as mentioned in RFP/Tender Inquiry. Unless otherwise stipulated, the Tender Document can be downloaded from CWC website [www.cewacor.nic.in](http://www.cewacor.nic.in) or from e-tender website <https://etenders.gov.in/e procure/app> free of cost. If the Procuring Entity happens to be closed on the deadline for submitting the bids as specified above, this deadline shall not be extended. - 1.3. **Clarifications-** A Bidder requiring any clarification regarding the RFP/Tender Document may ask questions in writing/ electronically from Office/ Contact Person as mentioned in E-Tender Inquiry/RFP, provided the questions are raised before the clarification end date mentioned above. This deadline shall not be extended in case of any intervening holidays.

**2. Submission of Bids:**

- i) Bids must be uploaded only on GePNIC portal till the deadline for submission mentioned in RFP/Tender Inquiry. If the office happens to be closed on the deadline to submit the bids as specified above, this deadline shall not be extended.
- ii) No manual Bids shall be made available or accepted for submission. Bidder must comply with the conditions of the eProcurement portal of GePNIC, including registration, compatible Digital Signature Certificate (DSC) etc. In the case of downloaded documents, Bidder must not make any changes to the contents of the documents while uploading, except for filling in the required information.
- iii) EMD of amount as mentioned in RFP/E-Tender Inquiry to be paid in favour of Central Warehousing Corporation, New Delhi only through e-payment gateway of e-procurement of GePNIC & receipt of same should be scanned and uploaded on the e-tendering website <https://etenders.gov.in/> eprocure/app along with etender documents.
- iv) Cost of tender (Non refundable) as mentioned in RFP/E-Tender Inquiry to be paid only through e-payment gateway of e-procurement system of GePNIC. Proof should be submitted/uploaded with the tender.
- v) Tender processing fee (Non-refundable) would be paid mandatorily on e-payment gateway of e-procurement system of GePNIC.
- vi) Integrity Pact: If so indicated, in the RFP/E-Tender Inquiry, all Bidders shall have to sign the Integrity Pact with the Procuring Entity as per 'Annexure-V: Integrity Pact'. Bids without a signed Integrity Pact shall be rejected.

3. **Bid Opening-** Bids received shall be opened online at the specified date and time given in RFP/E-Tender Inquiry. If the office is closed on the specified date of opening of the bids, the opening shall be done on the next working day at the same time.

4. **Disclaimers and Rights of Procuring Entity-** The issue of the Tender Document does not imply that the Procuring Entity is bound to select bid(s), and it reserves the right without assigning any reason to: a) reject any or all the Bids, or b) cancel the tender process; or c) abandon the procurement of the Services; or d) issue another tender for identical or similar Services

- A. All the bidders are requested to get themselves registered well in advance and no extra time will be consider for the delay in online vendor registration for any reason whatsoever. In case, bidders wait till the last moment for uploading tenders/bid, and if any technical problem is encountered at that time, the bid submission time may elapse. In any event, for any reason whatsoever, in case the bid is not submitted within the bid submission time, CWC shall not be responsible, in any manner whatsoever, for such failure and such unsuccessful attempts shall be treated as non-participation in the tender without permissibility to contest the same or to seek a refund of processing fee/tender cost, if deposited.
- B. However, if valid class III digital signature is already available with the bidder, the same can be used for CWC tender.
- D. The person authorized to participate in the bidding on behalf of the bidder i.e., authorized signatory, can submit the bid under digital signature none other than the one issued to him. Any non-compliance with this stipulation will lead to summarily rejection of the bid.
