Commodity EXIM Report **DGCI & S, I T J Division**

The weekly EXIM Report published by ITJ Division of DGCI&S, Kolkata presents some basic insights into India's export and import trade patterns w.r.t. selected set of commodities identified each week in order to facilitate preliminary commodity group/sector specific analysis for better policy making.

2. For both categories of trades, one commodity group is chosen from the entire ITC-HS 4-digit Classification (latest being 2023-2024 classification system). The Indian Trade Classification based on Harmonized System has been adopted in India for Export and Import Operations. While India specific data is sourced from DGCI&S, M/o C & I Database, global export-import data of exactly those sets of commodities are sourced from UN-COMTRADE Database.

3. As regards the time-period, this report outlines trade statistics over a period of four years. Currently (for reports being prepared in FY 2023- 2024) we are considering the time-period of 2020-2021 to 2023-2024(Financial year data). The latest finalized data available on the UN Comtrade Database is only up to year 2023 (Calendar Year) and on the DGCI&S Database up to April, 2024. So, for each commodity group dealt in this report, trends from 2020 to 2023 have been showcased where data has been sourced from UN Comtrade and from 2020-2021 to 2023-2024 when sourced from DGCI&S database; however, for computation of commodity group's share in India's overall export basket and import basket we have had to use FY (financial year) data as all aggregate level data in India are represented in FY format.

4. In the instant report [2nd weekly Commodity Exim Report of May,2024 dated 8th May, 2024] the following two commodities have been dealt with.

Export: Bed Linen, Table Linen, Toilet Linen etc [ITCHS Code – 6302] - In FY 2023-2024 (April,2023 – March,2024) this commodity group has 0.43% share in India's total Export value basket as per DGCI&S data base. India had occupied the 3rd slot in export of this commodity with (1794.37 million USD) with 8.58% share of total global exports in the year 2023 – 2024.

Import : Acyclic Alcohols and their halogenated derivatives. [ITCHS Code – 2905] – In FY 2023-24 (April 2023 – March,2024) this commodity group had share of 0.35% in India's total Import value basket as per DGCI&S data base. India having 8.23% share of total global imports of this commodity occupied the 2nd slot in the 2023.

EXPORT

Bed Linen, Table Linen, Toilet Linen etc classified as **ITCHS Code – 6302** falls under Chapter - 63(Other Made up Articles; Sets; Worn Textile Articles; Rags) of Section- XI (Textile and Textile Articles) of ITC-HS classification.

India is engaged in the process of exporting this commodity and in 2023-2024 FY this commodity group has so far (April,23-March,2024) had 0.43% share in India’s total Export value basket as per DGCI&S data base.

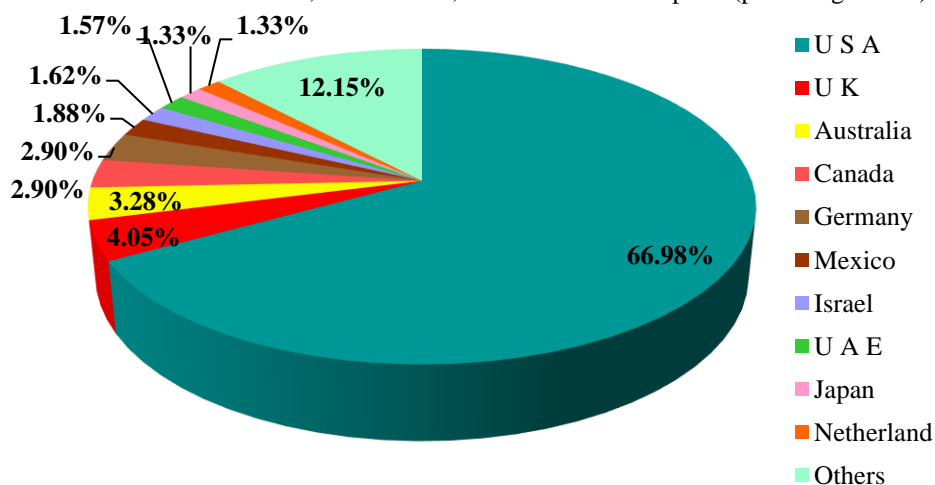

India’s top 10 destinations of Bed Linen, Table Linen, Toilet Linen etc Exports (percentage share) in 2023-2024



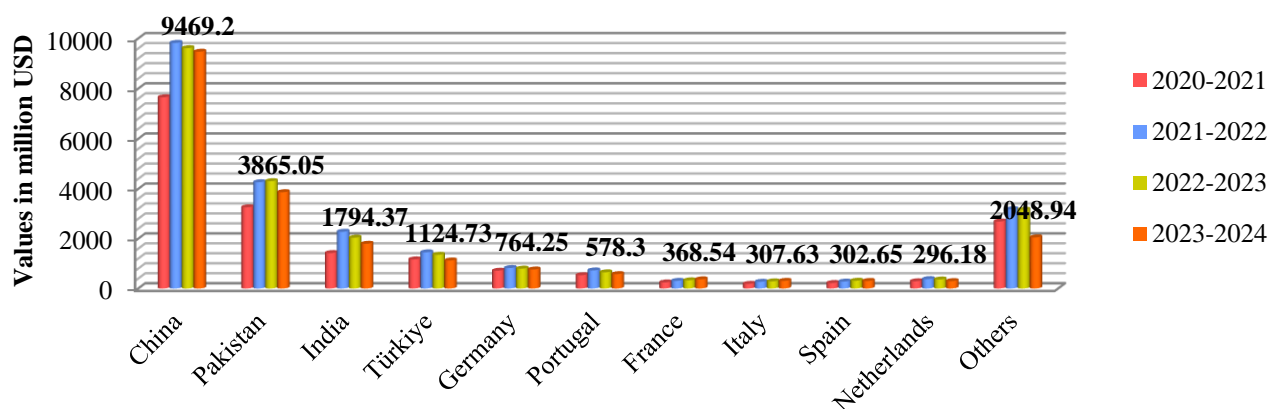
The total value of exports of Bed Linen, Table Linen, Toilet Linen etc from India amounted to US\$ 1858.84 million in 2023-2024 with a little dip of 2.44% compared to 2022-2023 figures of US\$ 1905.21. For, the period under review, exports of Bed Linen, Table Linen, Toilet Linen from India were at US\$ 1566.33 million in 2020-2021 followed by a steep rise in 2021-2022, a moderate dip in 2022-2023 followed by again a little dip in 2023-2024. USA (importing US\$ 1245.05 million worth of goods in this segment from India) has held the top slot as an export destination in this segment. Followed distantly by UK (US\$ 75.35 million) and Australia(US\$ 61.04 million) to where India exported around 4.05% and 3.28% share of Bed Linen, Table Linen, Toilet Linen etc respectively in 2023-2024.

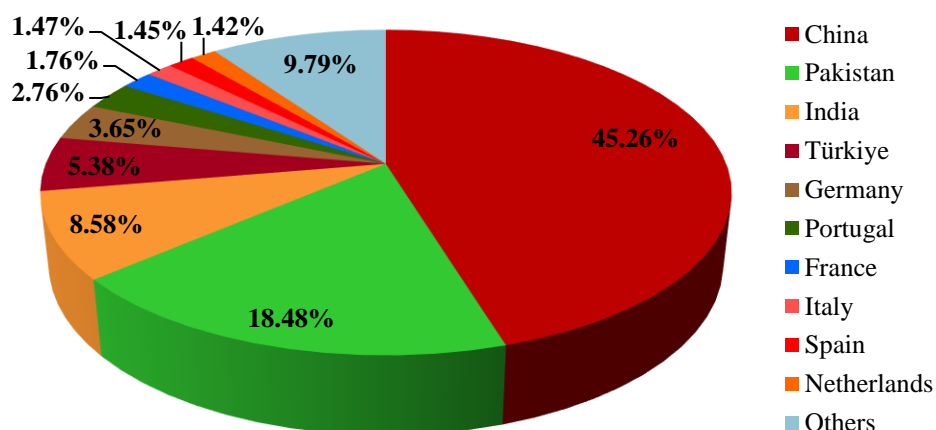

World's 10 leading exporters of Bed Linen, Table Linen, Toilet Linen etc by percentage share in 2023:



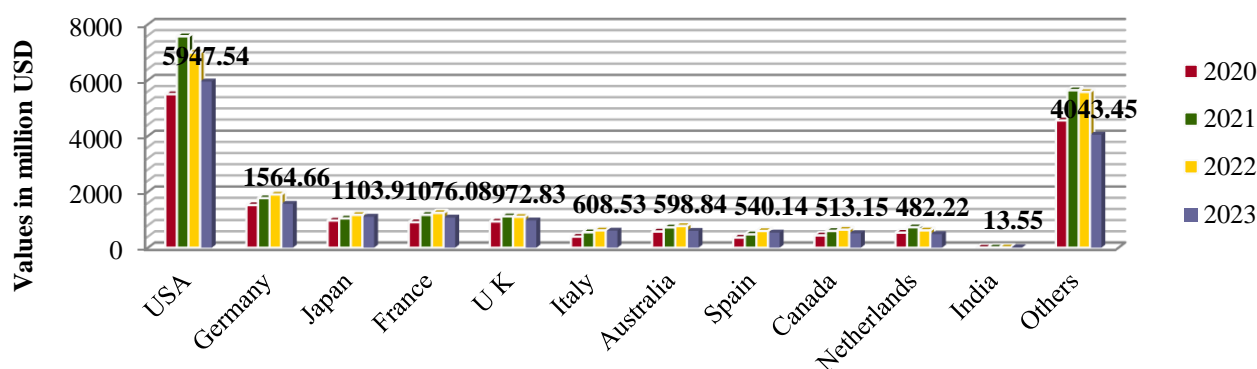
The Bed Linen, Table Linen, Toilet Linen etc exports globally amounted to US \$ 20919.83 million in 2023 with a decreasing by 9.86% over the previous year. **India's** exports in this segment amounted to US\$ 1794.37 million in the year 2023 as per UN Comtrade database and **India** ranked 3rd in the world with the share of 8.58% of total global exports of this commodity. The lead exporters in this segment has been China (US \$ 9469.20 million) and Pakistan(US\$ 3865.05 million) occupied the top two slots with the highest levels of exports in 2023, with 45.26% and 18.48% shares of global exports of Bed Linen, Table Linen, Toilet Linen etc in 2023 respectively.

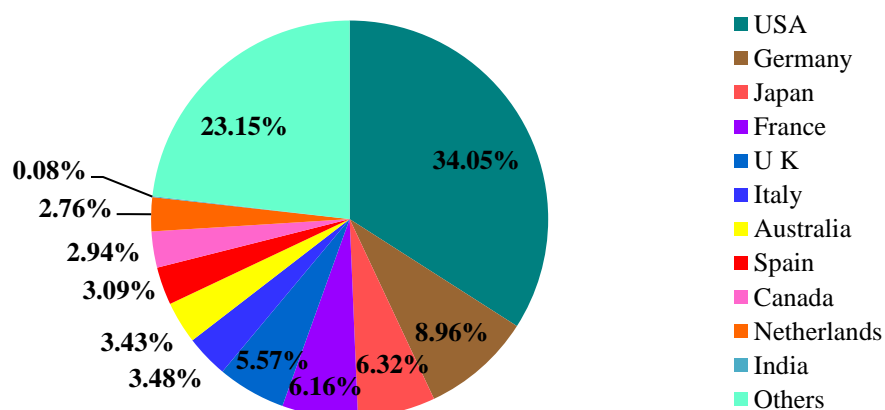

World's 10 leading importers of Bed Linen, Table Linen, Toilet Linen etc by percentage share in 2023



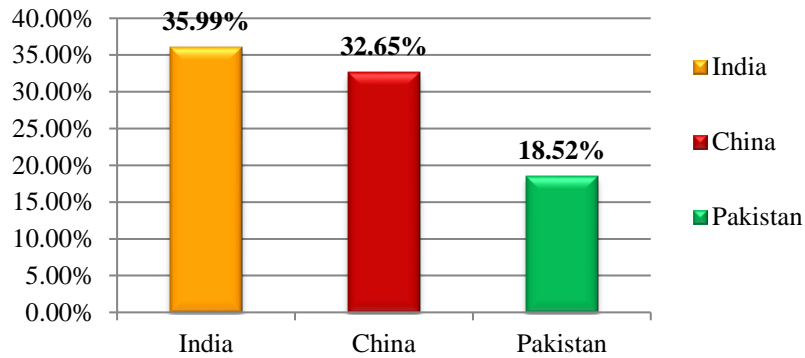
The Bed Linen, Table Linen, Toilet Linen etc. imports worldwide was US\$ 17464.88 million in 2023 decreasing by 17.86% from 2022 levels. The lead importer in this segment in 2023 has consistently been USA(34.05%) in 2023, distantly followed by Germany (8.96%) and Japan(6.32%). India with a show of only 0.08% in this category, stood at 57th position globally. Global imports in this segment had increased in 2021 compared to the year 2020 and then steadily decreased from 2021 till 2023.

A difference is observed between global exports and global imports of this segment as per UN Comtrade statistics. In 2023 global exports exceeded global imports by US\$ 3461.95 million.

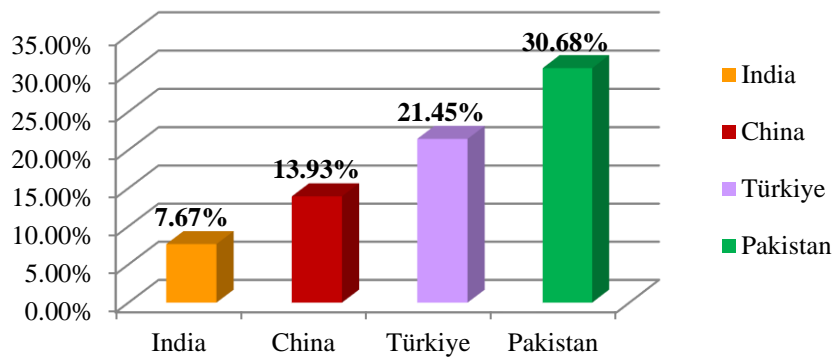
As per UN Comtrade database in 2023 the top 3 importers of Bed Linen, Table Linen, Toilet Linen etc globally were **USA, Germany and Japan**.

These 3 Country have imported 35.99%, 7.67% and 2.25% share of Bed Linen, Table Linen, Toilet Linen etc from India in 2023 which are represented below:

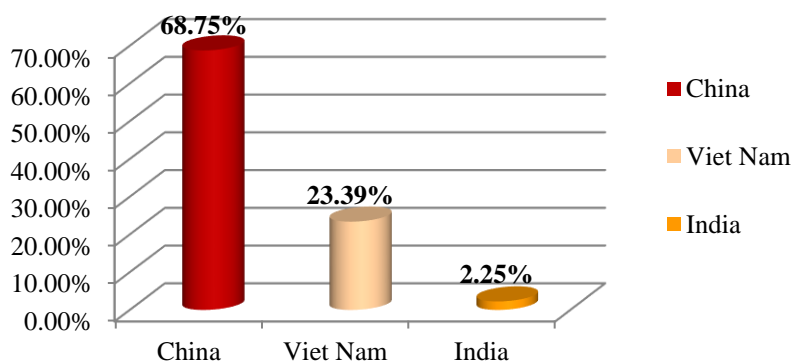
Top 4supplier nations of Bed Linen, Table Linen, Toilet Linen etc to USA in 2023 (percentage share):

India is engaged in the process of exporting this commodity and in FY 2023 –24 (April,2023 – March,2024) this commodity group had share of 0.35% share in India’s total Import value basket as per DGCIS data base **Table**

In 2023-2024 India had imported a total of US\$ 2335.26 million worth of Acyclic Alcohols and their halogenated, sulphonated and Nitrated derivatives. As per available data, Saudi Arab stood out as India’s top importing partner in this segment with a share of 16.91%, followed closely by Kuwait and Oman with shares of 15.54% and 13.28% respectively. India’s import value in this segment had a huge jump in 2021-2022 over the year 2020-2021 with a continuing trend till 2022-2023 and a moderate dip in 2023-2024.

Worldwide import of Acyclic Alcohols and their halogenated, sulphonated and Nitrated derivatives totaled to US\$ 29980.67 million in 2023 recording a 34.65% dip over 2022 levels. The import value of Acyclic Alcohols and their halogenated, sulphonated and Nitrated derivatives in **India** amounted to US\$ 2466.24 million in 2023 as per UN Comtrade database and **India** ranked 2nd in the world with the 8.23% share of global imports of this commodity. The lead importer in this segment has been China (US\$ 9673.04 million) with 32.26% share of world imports in 2023. USA (US\$ 1843.14 million) occupied 3rd slot with 6.15% share of global imports of this commodity in 2023.
