The Karnataka Slum Development Board (KSDB) Bengaluru invites item rate tenders for the Construction of Houses including infrastructure works for the slum dwellers of Ranibennur, & Udupi city under PMAY (U) –HFA scheme with convergence of state housing schemes, from the eligible class-1 registered KPWD/CPWD contractors. The tenderers shall submit in two cover System tenders for the works shown in the table below through c-procurement portal of the Government of Karnataka only (viz., http://eproc.karnataka.gov.in). Tender documents may be downloaded from Government of Karnataka web site http://eproc.karnataka.gov.in/eportal/index.seem under the login of contractors. After login please scroll down to the right bottom to see list of tenders, please click there to find the details of IFT and download copy of tenders as per prescribed date and time published in the portal only. Interested contractors who wish to participate should remit online transaction fee for tender after registering in the e-portal. The transaction fee is non-refundable. The technical bids along with EMD and financial bids are to be submitted in e-portal as per the instructions in the bidding documents.

The technical bids of the Agencies who satisfy the requirement of payment of EMD and other terms as per bidding documents will be opened first and the financial bids of the technically qualified bidders as per prescribed prequalification criteria will be considered, work comprises construction of single story / multi-level houses as detailed below:
